**DOING IT AGAIN, INC.

Doing It Again, Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 7, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators David & Temple's Minimum Purchase Age Compliance Check Field Report.

FINDINGS OF FACT

1. On Tuesday, May 20, 2025, at approximately 7:49 p.m., Investigators David & Temple ("Investigators") conducted a compliance check at Doing It Again, Inc.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 12-ounce bottle of Bud Light beer for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2018.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a WARNING.
