Also, SDO has proposed the expansion of opportunities made available to diverse and small businesses by including supplier diversity terminology in Commonwealth grants as well as expanding the state-funded construction projects that fall under the Municipal Construction Affirmative Marketing Program. SDO also recently signed a Memorandum of Understanding with National Veteran Owned Business Association (NaVOBA) where their certified businesses will now be accepted by SDO as third party certifications.
