DECISION

**THE BELLADORA CORPORATION D/B/A THE VIN BIN
22 SOUTH STREET
HOPKINTON, MA 01748

The Belladora Corporation d/b/a The Vin Bin (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 15, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Keefe's Report.

The following documents are in evidence:

1. Investigator Keefe's Compliance Check Field Report;
2. Licensee Stipulation of Fact;
3. Copy of New License Application Approval 11/15/2012;
4. Receipt for Alcohol Purchase.

There is one (1) audio recording of this hearing.

FACTS

1. On Wednesday, June 5, 2019, at approximately 7:05 p.m., Investigators Di Cicco and Keefe ("Investigators") investigated the business of The Belladora Corporation d/b/a The Vin Bin.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 6-pack of Budweiser beer for six dollars and seventy-nine cents (\$6.79). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2012 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
