DECISION

SIEGAL AND SONS INVESTMENT LTD D/B/A MARTY'S 61 MAIN STREET HOPKINTON, MA 01748 LICENSE#: 00011-PK-0544

Siegal and Sons Investment Ltd d/b/a Marty's ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, June 24, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Temple & David's Minimum Purchase Age Compliance Check Field Report.

FINDINGS OF FACT

- On Wednesday, April 1, 2025, at approximately 6:00 p.m., Investigators Temple & David ("Investigators") conducted a compliance check at Siegal and Sons Investment Ltd d/b/a Marty's.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25-ounce can of High Noon Peach for five dollars and ninety-nine cents (\$5.99). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since pre 2015 with no previous violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
