DECISION

SIEGAL AND SONS INVESTMENT LTD D/B/A MARTY'S
61 MAIN STREET

Siegal and Sons Investment Ltd d/b/a Marty's ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, June 24, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Temple & David's Minimum Purchase Age Compliance Check Field Report.

 2. ABCC Form 43, Transfer of License Approval, 11/27/2015;
 3. Licensee Stipulation of Facts.

FINDINGS OF FACT

1. On Wednesday, April 1, 2025, at approximately 6:00 p.m., Investigators Temple & David ("Investigators") conducted a compliance check at Siegal and Sons Investment Ltd d/b/a Marty's.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25-ounce can of High Noon Peach for five dollars and ninety-nine cents (\$5.99). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since pre 2015 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
