DECISION

HUDSON WINE & SPIRITS INC. D/B/A CHUBBY'S LIQUORS 105-107 MAIN ST. HUDSON, MA 01749 LICENSE#: 054800031 VIOLATION DATE: 05/23/2016 HEARD: 11/15/2016

Hudson Wine & Spirits Inc. d/b/a Chubby's Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 15, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Bailey's Report.

The following documents are in evidence:

- 1. Investigator Bailey's Compliance Check Field Report dated May 23, 2016;
- 2. Licensee's Stipulation of Facts; and
- 3. Photograph of Underage Operative.
- A. Various Letters from Hudson Police Department and Others re: Licensee's Passing Local Area Compliance Checks.

The Commission took Administrative Notice of the Licensee's record.

FACTS

1. On Monday, May 23, 2016, at approximately 5:46 p.m., Investigators Doyle and Bailey ("Investigators") investigated the business operation of Hudson Wine & Spirits Inc. d/b/a Chubby's Liquors.

2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 24-ounce can of Budweiser beer for two dollars and seventy-five cents (\$2.75). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 25 years with no prior violations, the Commission issues a WARNING.
