RHL09 INC. D/B/A FENG RESTAURANT 191 WASHINGTON STREET HUDSON, MA 01749

RHL09 Inc. d/b/a Feng Restaurant ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 10, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Keefe and Quinn's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigator Keefe and Quinn's Minimum Purchase Age Compliance Check Field Report, 5/2/2023;
- 2. ABCC Form 43, Transfer of License Approved 6/17/2015;
- 3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Tuesday, May 2, 2023, at approximately 7:19 p.m., Investigators Keefe and Quinn ("Investigators") conducted a compliance check at RHL09 Inc. d/b/a Feng Restaurant.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one Sapporo beer, for six dollars and ninety-six cents (\$6.96). The underage operative was not asked for identification.
- 3. Chang Lin, Licensee, appeared at the Commission hearing. The Licensee has held a license under M.G.L. c. 138, § 12 since 2015 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
