FINAL DECISION

In accordance with the Adjudicatory Proceeding Rules at 310 CMR 1.01(14)(b), Bonnie Heiple, Commissioner of the Massachusetts Department of Environmental Protection ("MassDEP" or "the Department"), has designated me the Final Decision-Maker in this administrative appeal.¹

I have reviewed and hereby approve the attached Settlement Agreement by Administrative Consent Orders with Penalty ("ACOPs") and Notice of Noncompliance ("NONs") executed on May 8, 2025 by William B. Hull, GP for Hull Forestlands, LP., and by Thomas J. Rosati, Vice President for John's Trucking of Agawam, Inc. and on May 15, 2025 by Micheal Gorski, Regional Director for the Massachusetts Department of Environmental Protection ("the Department" or "MassDEP") (ACOPs 00018952 and 00018620), to settle this appeal.
