DECISION

B AND L BRIDGE STORE LLC D/B/A BRIDGE STORE PACKY
3 EAST MAIN ST.
HUNTINGTON, MA 01050
LICENSE#: 055800016

B and L Bridge Store LLC d/b/a Bridge Store Packy (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Wednesday, December 14, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Carey's Report.

The following documents are in evidence:

1. Investigator Carey's Compliance Check Field Report dated August 17, 2016; and
2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

1. On Wednesday, August 17, 2016, at approximately 7:26 p.m., Investigators Temple and Carey ("Investigators") investigated the business operation of B and L Bridge Store LLC d/b/a Bridge Store Packy.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 16 ounce can of Budweiser Light beer for one dollar and forty-four cents (\$1.44). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission **suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
