Overview

This letter transmits revisions to the service codes in the *Independent Diagnostic Testing Facility Manual*. These revisions reflect 2026 updates to applicable Current Procedural Terminology (CPT) and Healthcare Common Procedure Coding System (HCPCS) codes. For dates of service on or after January 1, 2026, you must use the new codes in order to obtain **reimbursement**. “IC” indicates that the claim requires individual consideration. See 130 CMR 431.406 for more information.
