SUBJECT: Applicant Briefings for Emergency Disaster Declaration FEMA-3599-EM-MA for

Hurricane Lee

On September 15, 2023, the Commonwealth of Massachusetts received an Emergency Disaster Declaration (FEMA-3599-EM-MA) for all Massachusetts counties related to the anticipated landfall of Hurricane Lee. This Declaration has activated the Federal Emergency Management Agency (FEMA)'s Public Assistance (PA) Program, making federal funding available to local governments, state agencies, and certain private non-profit organizations for eligible disaster-related emergency protective measures (Category B) limited to mass care activities, including evacuation, sheltering support, and EOC operations.

The initial step in seeking funding associated with the Declaration is to participate in an Applicant Briefing, which provides the details on eligible expenses and costs incurred as a result of this event as well as the reimbursement process for applying and receiving federal funds under the PA Program.

The Massachusetts Emergency Management Agency (MEMA) will conduct two (2) virtual Applicant Briefings via webinar. The schedule for the briefings is detailed below. Registration is required and is available through the links in the schedule below. It is imperative that appropriate representatives from your community, agency, or organization, including a representative for your fiscal department,
