VERY IMPORTANT NOTICE

IMPORTANT UPDATE: TIER 1 PUBLIC NOTICE (PN) INSTRUCTIONS AND TEMPLATE FOR THE REVISED TOTAL COLIFORM RULE

Attention Public Water Suppliers,

Massachusetts Department of Environmental Protection (MassDEP) Drinking Water Program (DWP) has made critical updates to the **Tier 1 PN (Boil Water Order) instructions** as well as associated templates for the **Revised Total Coliform Rule (RTCR)**.

MassDEP/DWP Public Notification (PN) regulations (310 CMR 22.16) include specific requirements for notifying the public of all emergencies involving violations of drinking water regulations. If a "Do Not Drink," "Boil Water," or "Do Not Use" order is issued, the public notice process should be initiated immediately upon determination by MassDEP/DWP and comply with the public notification and reporting requirements of 310 CMR 22.00. Tier 1 PNs, which are required for violations and situations with significant potential to have serious adverse effects on human health as a result of short-term exposure, require PWS to provide public notice to their impacted consumers within 24 hours of learning of the emergency. During this 24-hour period, PWS must also contact and consult with their MassDEP/DWP Regional Office to determine any additional PN requirements.

Specific updates have been made to the following sections of the RTCR Tier 1 PN template:

• Population Served, pg. 2

 PWS must distribute PNs to all consumers impacted by the specific situation. This may include consumers outside the PWS's town boundaries if the PWS serves residents in neighboring communities.

- PWS must include in their PNs and other communication specific information about the service area impacted by the emergency, especially if part of the service area is located in neighboring communities.
- PWS must list the specific community or communities including any streets in neighboring communities served by your PWS.

• PN Translation Requirements, pg. 3

- If your PWS serves a community with 10% or more, or greater than 1,000 people of non-English speaker consumers, your PN must contain a statement in the appropriate language(s) regarding the importance of the report.
- If your PWS serves a community where 25% or more of your consumers speak one particular language, you must translate the entire PN report into that specific language and have the translated version immediately available upon request.

MassDEP DWP strongly recommends that PWS have all PN outreach materials prepared and pre-approved as part of their Emergency Response Plans (ERP) so that in an emergency, these resources can be quickly customized and disseminated to all relevant parties.

PWS Action Requested

- 1. Please review the attached updated Instructions, PN Template and attachments.
- PWS must update their Tier 1 RTCR Templates (Boil Water Order PN template) and be ready to use the updated template when there is a violation requiring a Tier I- Boil Water Order Notice.
 - If PWS opt to use their own templates or language for public notification, they must obtain pre-approval from their MassDEP/DWP Regional Office prior to the dissemination of these documents
