

INITIATIVE PETITION FOR A LAW TO REQUIRE COMPLIANCE WITH THE CURRENT  
ABSENTEE BALLOT PROCEDURE FOR EARLY MAIL-IN VOTING IN MASSACHUSETTS

*Be it enacted by the People, and by their authority:*

**SECTION 1.** To enhance the integrity of the voting process in the Commonwealth, while preserving voters' ability to vote early in-person and by mail using the current absentee ballot procedure, Section 25B of Chapter 54 of the General Laws is hereby amended by striking out subsection (a), in its entirety including paragraphs (1) through (14), inclusive, thereof, and inserting a new subsection (a) that states, "Any registered voter wanting to vote early by mail may do so pursuant to Sections 86 through 103 of Chapter 54 of the General Laws provided that the registered voter is eligible to vote pursuant to at least one of the Sections 86 through 103 of Chapter 54 of the General Laws."

**SECTION 2.** This initiative shall be effective upon passage.
