BRP WW 25 Test Project Permit

Instructions and Supporting Materials

Prerequisites to Completing the Online ePLACE Application:

- **Project Description** prepare a statement that describes the proposed project and how it meets the definition of a Test Project: the installation or deployment of water dependent Innovative Technology in situ for purposes of evaluating its performance and environmental effects.
- **Regulatory Standards** prepare documentation of how the project will meet the standards at 310 CMR 9.32-9.55 during operation of the project.
- **Application** review and complete the Application Proof of Signature and have the document executed by the applicant and property owner.
- Wetlands Protection Act Documentation plans submitted with a Notice of Intent or referenced in an Order of Conditions under the Wetlands Protection Act, M.G.L. c. 131, § 40, shall accompany the application. In lieu of plans prepared by a Registered Professional Engineer or Registered Land Surveyor, the applicant shall show the proposed Project Site on a plan designating all project components by coordinates referenced to the Massachusetts State Plane Coordinate System.
- Chapter 91 Plan prepare a plan for installing, testing, and removing project components.
- Public Notice download the template and enter the project-specific information and save/print the document. Select a Notification Date that will coincide with the newspaper publication date and provide sufficient time to complete the mailing notification to all parties.
 - Complete publication and mailing concurrently:
 You must send the Public Notice by certified mail, return receipt requested
 and provide proof of such notice to the Department
 - a. Publish the Public Notice in a newspaper of general circulation in the area where the project is located on or before the Notification Date
 - b. Mail the Public Notice and project plans on or before the Notification Date to:
 - MassDEP Waterways Program (<u>dep.waterways@mass.gov</u>) or 1 Winter Street, 5th Floor, Boston, MA 02108
 - ii. Municipal Official (Mayor and City Council or Select Board)
 - iii. Planning Board
 - iv. Harbormaster
 - v. Conservation Commission
 - vi. Martha's Vineyard Commission or Cape Cod Commission (if the project is located within the jurisdiction of said Commissions
 - vii. Massachusetts Office of Coastal Zone Management (if the project is located within the Coastal Zone)
 - viii. Massachusetts Department of Conservation and Recreation (if the project is located within an Ocean Sanctuary)
 - ix. Massachusetts Department of Fish and Game
 - x. The Environmental Monitor (if the project exceeds the review thresholds for Waterways at 301 CMR 11.03
 - xi. Abutters the owner of land that shares, along the water's edge, a common boundary or corner with a project site, as well as the owner of land that lies within 50-feet across a water body from such site.

xii. All Property Owner(s) (if different from the applicant)

xiii. Interested Parties: any person having a record easement interest in the property.

Failure to properly publish and notify all parties could result in a deficiency in the Public Notice and a requirement to re-notice the project. Please contact dep.waterways@mass.gov with any questions about this part of the process.

• **Proof of Publication/Certified Mail Receipts** – copy or scan the certified mail receipts and the newspaper tear sheet for submittal to the Department.
