DECISION

ITHAKI INC. DBA ITHAKI RESTAURANT 25 HAMMATT STREET IPSWICH, MA 01938 LICENSE#: 0566-00056

VIOLATION DATE: 06/02/2017 HEARING DATE: 08/08/2017

Ithaki Inc. d/b/a Ithaki Restaurant (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 8, 2017, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Bailey's Report.

The following documents are in evidence:

- 1. Investigator Bailey's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

<u>FACTS</u>

- 1. On Friday, June 2, 2017, at approximately 7:00 p.m., Investigators Di Cicco and Bailey ("Investigators") investigated the business operation of Ithaki Inc. d/b/a Ithaki Restaurant.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Bud Light beer for four dollars and twenty-eight cents (\$4.28). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for a period of three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
