## DECISION

THUNDER ROAD LIQUORS INC. DBA IPSWICH BEVERAGE 146 E HIGH ST. IPSWICH, MA 01938 LICENSE#: 056600034 VIOLATION DATE: 05/14/2014 HEARD: 12/16/2014

Thunder Road Liquors Inc. dba Ipswich Beverage (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 16, 2014, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: c. 138, §34 Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Bailey's Report.

- 2. Investigator Bailey's Compliance Check Field Report dated May 14, 2014.

## <u>FACTS</u>

- 1. On Wednesday, May 14, 2014, at approximately 5:13 p.m., Investigators Temple and Bailey conducted an investigation of the business operation of Thunder Road Liquors Inc. dba Ipswich Beverage.
- 2. An underage operative, working with investigators, purchased a twenty-five ounce (25 oz.) can of Budweiser Light beer for two dollars and fifteen cents (\$2.15). The underage operative was not asked for identification.

## CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
