"(Full legal name of motor vehicle repair shop) has incurred fines or penalties for violation of Mass Gen Laws c. 100A in the amount if the attached Draft."

or

"A creditor(s) has obtained final judgment against (full legal name of motor vehicle repair shop) on a claim(s) arising in connection with business done under a certificate of registration granted under Mass Gen. Laws c. 100A in the amount of the attached draft and notice of such claim(s) was filed with the Director of Standards prior to the expiration of sixty days from the return or surrender of said certificate of registration or the date of the filing of an affidavit of its loss"

Partial drawings are permitted.

This Letter of Credit shall be automatically extended for an additional period of one year from present or each future expiration date unless we have notified you in writing, not less than ninety (90) days before such expiration date, that we elect not to renew the Letter of Credit for an additional period.

It is a condition of this Letter of Credit that it shall be extended without amendment for a period of one year from the then present expiration date upon our receipt within validity of the credit of the following statement purportedly signed by an authorized official of the Commonwealth of Massachusetts, Division of Standards, Reading as follows:
