### MEMA to Create a Multi-year Earthquake Program Strategy

MEMA, supported by Armada Ltd., is partnering with New England area earthquake experts to develop a multi-disciplinary Earthquake Mitigation Program for the Commonwealth. This group will develop and implement strategies to increase earthquake awareness, preparedness and education, and mitigate earthquake related risks in Massachusetts. Funding for this project is being provided by FEMA through the National Earthquake Hazards Reduction Program (NEHRP). Through this project, a series of stakeholder workshops are planned in multiple locations across the Commonwealth in late spring. This year's funding will end with an implementation partnership which will produce a multi-year earthquake program strategy report including a list of potential projects that may be implemented through future NEHRP grant funding.

Rich LaTour, who has been serving as the Acting Supervisor for MEMA's Planning Unit, has been named the Unit's full-time Supervisor. Rich previously served as a Local Coordinator in Region II.

# MEMA Staff and Northwest Massachusetts Incident Management Team (IMT) Assist Rhode Island with Gas Incident

Governor Charlie Baker <u>authorized</u> the Massachusetts Emergency Management Agency (MEMA) to send an eight person team from MEMA and an 11 person regional Incident Management Team to Rhode Island to assist with response and recovery efforts during their Aquidneck Island Gas Incident. MEMA staff and the IMT supported operations at the Rhode Island State Emergency Operations Center and the Unified Command Center in Newport, Rhode Island. The emergency workers were deployed to Rhode Island from January 23-28.

The request for assistance from the Rhode Island Emergency Management Agency was made directly to MEMA and was facilitated through the Emergency Management Assistance Compact (EMAC), which is the national emergency management mutual aid system that facilitates state-to-state disaster assistance. In 2018, MEMA deployed staff to Florida, Puerto Rico, North Carolina, Virginia, Hawaii and FEMA Headquarters to assist in the aftermath of natural disasters, and is proud to continue to support this tradition of providing aid to others in need.










#### 2019 Emergency Public Information Calendars Issued for Nuclear Emergency Planning Zones

The annual public information calendars have been mailed to residents of the 11 Massachusetts communities located within the 10 mile Emergency Planning Zones (EPZs) of the nuclear power stations located in Plymouth, MA and Seabrook, NH. The 2019 calendars are an important part of emergency planning, containing information that will better prepare families to respond to an incident at one of the nuclear power plants and to other emergencies within their communities.

## **Update on March 2018 Nor'Easters**

#### March 2-3 Storm (FEMA DR-4372)

On June 25, 2018, the Commonwealth received a disaster declaration authorizing FEMA Public Assistance funding for eligible applicants in the counties of Barnstable, Bristol, Essex, Nantucket, Norfolk, and Plymouth as a result of the March 2-3, 2018 severe winter storm and flooding event. Funding is authorized for an applicant's storm related costs including emergency work, as well as permanent repair and restoration of damaged facilities as a result of the storm event. FEMA has approved 125 Eligible Applicants for this disaster. All exploratory calls have been completed and 98% of Recovery Scoping meetings have been conducted with eligible applicants, to identify and document damages related to the event. To date, \$669,168 (federal share) has been obligated by FEMA to sub-recipients.

#### March 13 Storm (FEMA DR-4379)

On July 19, 2018, the Commonwealth received a disaster declaration authorizing FEMA Public Assistance funding for eligible applicants in the counties of Essex, Middlesex, Norfolk, Suffolk and Worcester as a result of the March 13-14, 2018 winter storm and snowstorm event. Funding is authorized for an applicant's storm related costs including snow removal, emergency work, and

permanent repair/restoration of damaged facilities as a result of the storm event. FEMA has approved 176 Eligible Applicants for this disaster. MEMA is working with FEMA to conduct exploratory calls (99% complete) and Recovery Scoping Meetings (98% complete) with all eligible applicants, to identify and document damages related to the event. To date, \$4,420,738 (federal share) has been obligated by FEMA to sub-recipients.
