

## **RECENT WINS!**

#### **Cape Cod Bridge Replacement**

Award of **\$372 million** from the Multimodal Project Discretionary Grant program for the phased replacement of the Cape Cod bridges, beginning with the Sagamore bridge.

An additional request of \$1.06 billion from the Bridge Investment Program (BIP) is still pending approval from USDOT.





#### Safe Streets and Roads for All

An additional **\$18 million** to Massachusetts communities from a second announcement of 2023 Safe Streets and Roads for All awards.

This funding includes \$14 million to the **City of Boston** for traffic signal operations design, as well as planning grants for the **Pioneer Valley Planning Commission, Central MA Regional Planning Commission, and 8 other municipalities.** 

#### **Clean School Buses**

**\$33 million** from the EPA Clean School bus program for 85 electric buses in **Boston**, **Worcester**, **New Bedford** and **Fall River**.






## STATE MATCHING FUNDS / TECHNICAL ASSISTANCE LEGISLATION

- Bill <u>S.2548</u> An Act to provide for competitiveness and infrastructure investment in Massachusetts, includes:
  - Creates a Commonwealth Federal Matching and Debt Reduction Fund that leverages interest earnings on the state's Stabilization Fund
  - Over the next three years, fund will unlock an estimated \$800 million in resources to pursue federal funding opportunities
  - \$50 million matching grants and loans for a local government infrastructure bank
  - \$12 million towards local government technical assistance
  - Adds to the over \$2 billion in existing resources
    Massachusetts has made available for state match to give
    Massachusetts a competitive edge in the pursuit of historic federal grant opportunities
- Passed unanimously by the Massachusetts
  Senate on Thursday, January 11th

- Total Funding: \$1,500,000,000
- Cost Share: 20%

  - "The goal of the RAISE program is to fund eligible surface transportation projects that will have a significant local or regional impact that advance the Departmental priorities of safety, equity, climate and sustainability, and workforce development, job quality, and wealth creation"

### DIRECT/ELECTIVE PAY

#### About

- <u>Direct Pay</u> makes clean energy tax credits effectively refundable for states, cities, towns, tribes, and other taxexempt organizations that otherwise do not file federal income taxes.
- Funded by the Inflation Reduction Act (IRA)

- 1. Meaningful involvement of all people with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies, including climate change policies
- Equitable distribution of energy and environmental benefits and environmental burdens



### **Meaningful Community Engagement**

### • Best Practices include:

- Provide interpretation and translation services
- Hold meetings that allow for in-person and remote participation (hybrid)
- Hold meetings in accessible locations
- Provide public transit reimbursements
- Ensure meetings are held at a reasonable time
- Use plain English NOT industry jargons
- Engage in creative outreach by partnering with community-based organizations, non-profits, faithbased organizations
- Use alternative media outlets to disseminate information
- Provide reasonable accommodations, such as food and childcare services
- Compensate for knowledge
- Iterative process



### **Meaningful Community Engagement**

- Environmental Justice Council
  - 15 members appointed by Governor
  - Meets every 2 months (sometimes more often)

### • Environmental Justice Table

- Statewide coalition external to government
- Convened by environmental justice groups

### • Justice40 Working Group

- Convened last fall by the Office of EJ and Equity
- Organizations from across the Commonwealth
- Meets monthly



### What is the Justice40 Initiative?

- Goal: at least 40 percent of the overall benefits of certain Federal investments flow to disadvantaged communities that are marginalized, underserved, and overburdened by pollution.
- The Justice40 Initiative is not a one-time investment, nor a single pot of money. It is a series of changes to improve how government ensures equitable distribution of the benefits of many programs. Agencies are changing their programs to ensure the benefits reach disadvantaged communities.
- Federal Mapping Tool: <u>Climate and Economic Justice Screening</u> <u>Tool (CJEST)</u>



### **Community Change Grants**

The EPA seeks to fund \$2 billion worth of projects that are <u>community driven</u> and advance <u>environmental justice for</u> <u>communities designated disadvantaged</u> <u>communities</u>.

Partnership between at least 2 CBOs or a CBO and a (local gov, tribe, higher ed institution).

Projects must be completed within 3 years

Community change grant specific technical assistance AVAILABLE:

- 1. For general projects
- 2. For resilience projects



### **Community Change Grants**

Track I - Community-Driven Investments / Infrastructure:

- Funds infrastructure
- Award size: \$<u>10-20 million each</u>
- EPA expects to award approximately \$1.96 billion for approximately 150 Track I awards.
  - 150 Nationwide awards
  - 1-2 per state possible
  - 6-8 per region
  - \$10-20 M grants

Track II – Meaningful Engagement for Equitable Governance:

- Funds engagement of disadvantaged communities in governmental processes to advance environmental and climate justice
- Award size: <u>\$1-3 million each</u>
- EPA will award approximately \$40 million for approximately 20 awards.



### There are 181 municipalities that are Rural and/or Small Towns.


Definition: Under 7,000 populations or less than 500 people per square mile.

## Over the last ten years, a majority of Rural and/or Small Towns have seen a decline in population or a growth rate slower than the statewide average of 7.4%.









### # of Business and employees and change over 5 years of Rural MA.

#### Statewide 10.9% increase in establishments










### Income in Rural MA, compared to state average, change over 5 years.

#### **Championing Key Rural Projects & Targeted Funding to Rural Towns**

Unlocking funding for space utilization and mill demolition or redevelopment

One Stop funding

Create a workable rural economic factor, similar to Gateway Communities, in order to direct funding and increase opportunities for private funding and raise the profile of our rural communities.

Cross secretariate – go after issues that are in the way of key projects.

#### Make Rural MA livable and workable

Who is working to do economic development in a town? With limited staff capacity. Planning staff.

Rural infrastructure is lacking – roads and water sewer capacity need to be addressed in order to grow.

Reducing burden to make funding easier to access.

Achieve some quick wins, example partnering with DOT to change the way Ch 90 funds are distributed (changing the formula is a longer goal) more immediate is a simple accounting change, send the communities the funds upfront and then get an accounting after the funds have been used-this benefits all communities not just rural.

Roads are not usable Ambulance services strains

To assist communities in their economic sustainability by facilitating connections among parties. Use the community's assets and actors to double down on strengths. Example by crossing traditional boundaries to share info with businesses, non-profits, community based organizations, state and federal partners.

### **Anne's Goals**



- Visit all 181 Rural Communities and create and maintain open lines of communication with the Town Administrators/Managers/Executive Secretary's so they know they are being heard. A dedicated "tab" on the Ec Dev website to make that communication easier.
- 2) Create a workable rural economic factor, similar to Gateway Communities, in order to direct funding and increase opportunities for private funding and raise the profile of our rural communities.
- 3) Achieve some quick wins, example partnering with DOT to change the way Ch 90 funds are distributed (changing the formula is a longer goal) more immediate is a simple accounting change, send the communities the funds upfront and then get an accounting after the funds have been used-this benefits all communities not just rural.
- 4) To assist communities in their economic sustainability example by crossing traditional boundaries to share info with non-profits, for profits, community based organizations, state and federal partners, create career pipelines for municipal jobs working with traditional and vocational high schools and community colleges.
- 5) To help preserve rural character while working on community legacy projects and listening to what the towns want and how the state can assist in getting them there.

## RURAL FEDERAL GRANT OPPORTUNITIES

### Advanced Transportation Technologies and Innovative Mobility Deployment (ATTAIN)

- To deploy, install, and operate advanced transportation technologies to improve safety, mobility, efficiency, system performance, intermodal connectivity, and infrastructure return on investment.
- 20% of total funding is set aside for rural projects
- Deadline: February 2, 2024

#### RAISE (Rural) (See slide 14 for more information)

- A project is designated as rural if it is located outside a Census-designated urban area that had a population greater than 200,000 in the 2020 Census
- Deadline: February 28th

#### **Rural Business Development Grant**

- This USDA program promotes economic development and job creation projects
- Eligibility: Government Entity, an Indian Tribe, or a Nonprofit entity primarily serving rural areas.
- Deadline: April 1, 2024

#### **Rural Surface Transportation Program (RURAL)**

- For rural surface transportation projects to increase connectivity, improve the safety and transit reliability, and generate regional economic growth and improve quality of life
- Expected to open in the late Spring per USDOT
