# **CCFA FY26 Reimbursement Rate Increase: Overview and Proposal for Consideration**

# Child Care Financial Assistance Rates

EEC reimburses early education and out-of-school time programs that serve families receiving EEC child care financial assistance with a daily per child reimbursement rate.

These rates subsidize costs and provide purchasing power for families receiving child care financial assistance.

**EEC's daily reimbursement rate for child care financial assistance is based on multiple factors including:**

Program Type



Child's Age



Location of Care



Type of Care



# Enabling Language for FY26 Rate Increase: FY25 Fair Share Supplemental Budget (H4227)

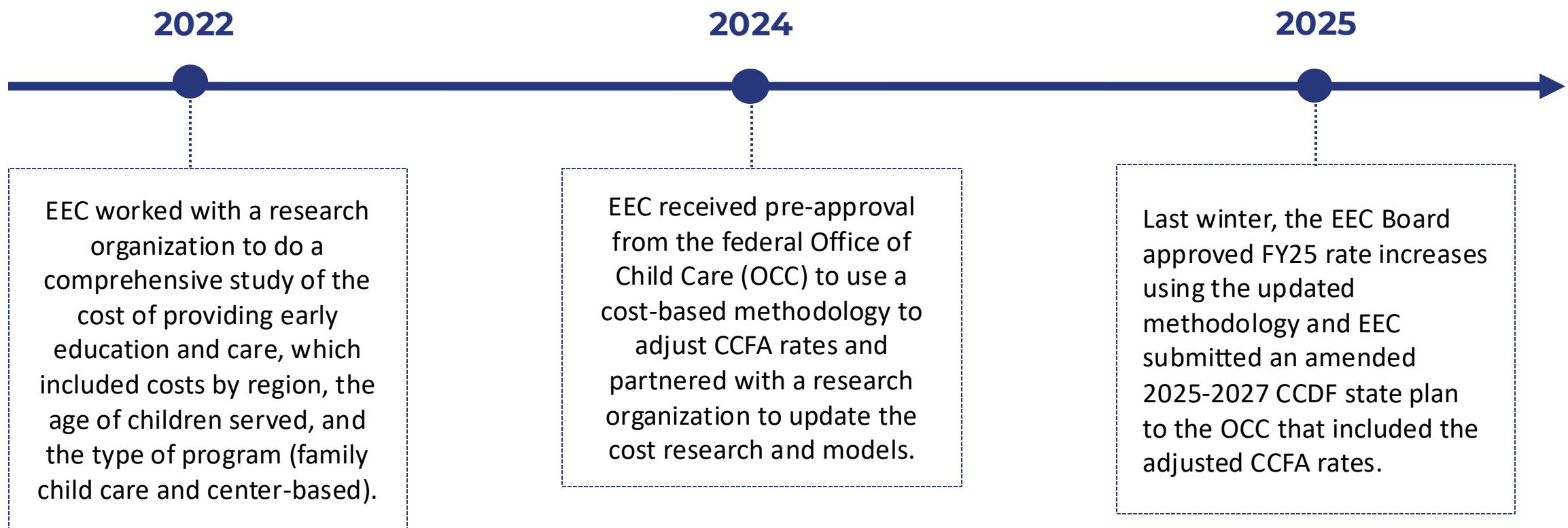
- For this fiscal year, \$20 million was appropriated through a "Fair Share" Supplemental Budget to be used to increase CCFA reimbursement rates for both centers and family child care. The line-item included the following language to direct expenditures:

1596-2511: "... provided further, that not less than **\$20,000,000 shall be expended for a reimbursement rate increase for subsidized early education center-based and family child care providers in the fiscal year ending on June 30, 2026 ...**"



# Recent Context: CCFA Rate Adjustments

EEC started research to develop a cost-based methodology in 2022. Since then, the team has continued to expand research and, when funding has been available through the annual state budget, to use the work to increase and reform CCFA rates to move them closer towards the cost of care.



# Cost of Care: High-Level Findings

## Cost Trends by Program Type

- The estimated cost of care per child for **center-based programs** increased between **14%** and **26%** from 2022 to 2024, depending on the region and age group served.
- The estimated cost of care per child for **family child care (FCC)** programs increased between **12%** and **19%** from 2022 to 2024, depending on the region and age group served.

## Cost Findings Compared to CCFA Rates

- Certain CCFA rates are both further from the cost of care and below median tuition prices, which can impact families' access to the market.
- Notable differences in cost of care are emerging across Western, Central, and Southeast regions (aligned regions that receive the same rates)
- Center-based rates for infants and toddlers and some preschool rates remain below the cost of care.
- FCC providers face similar costs for serving children under and over age 2, and FCC Over Age 2 rates are further from the cost of care.

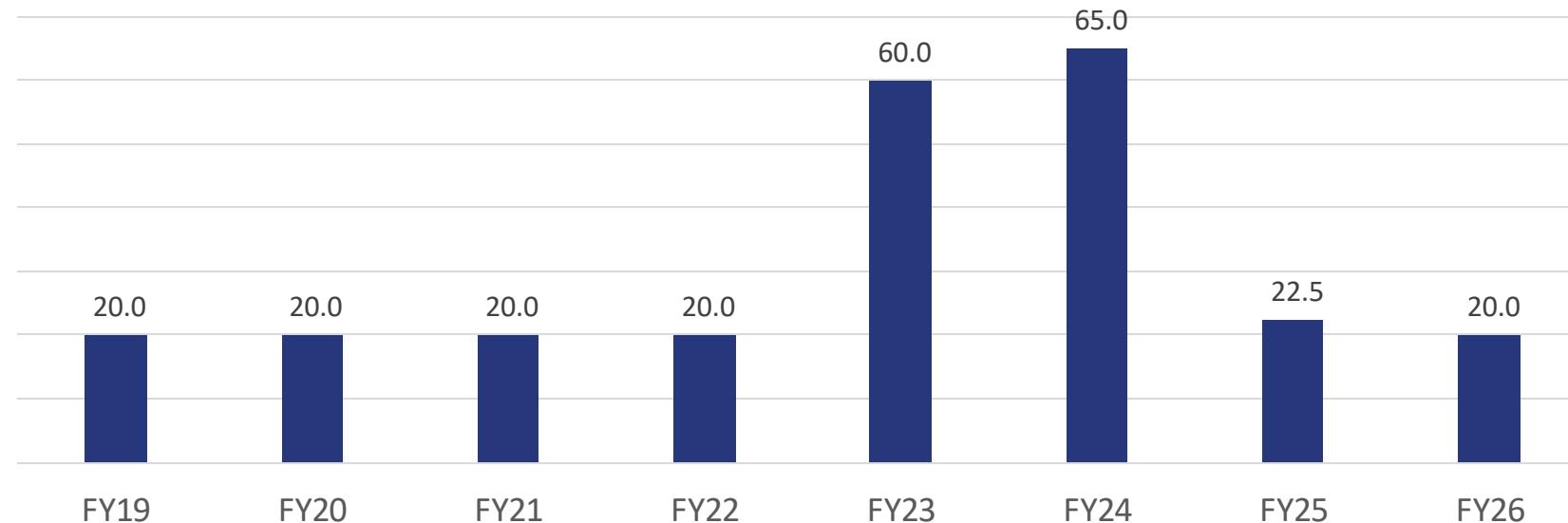

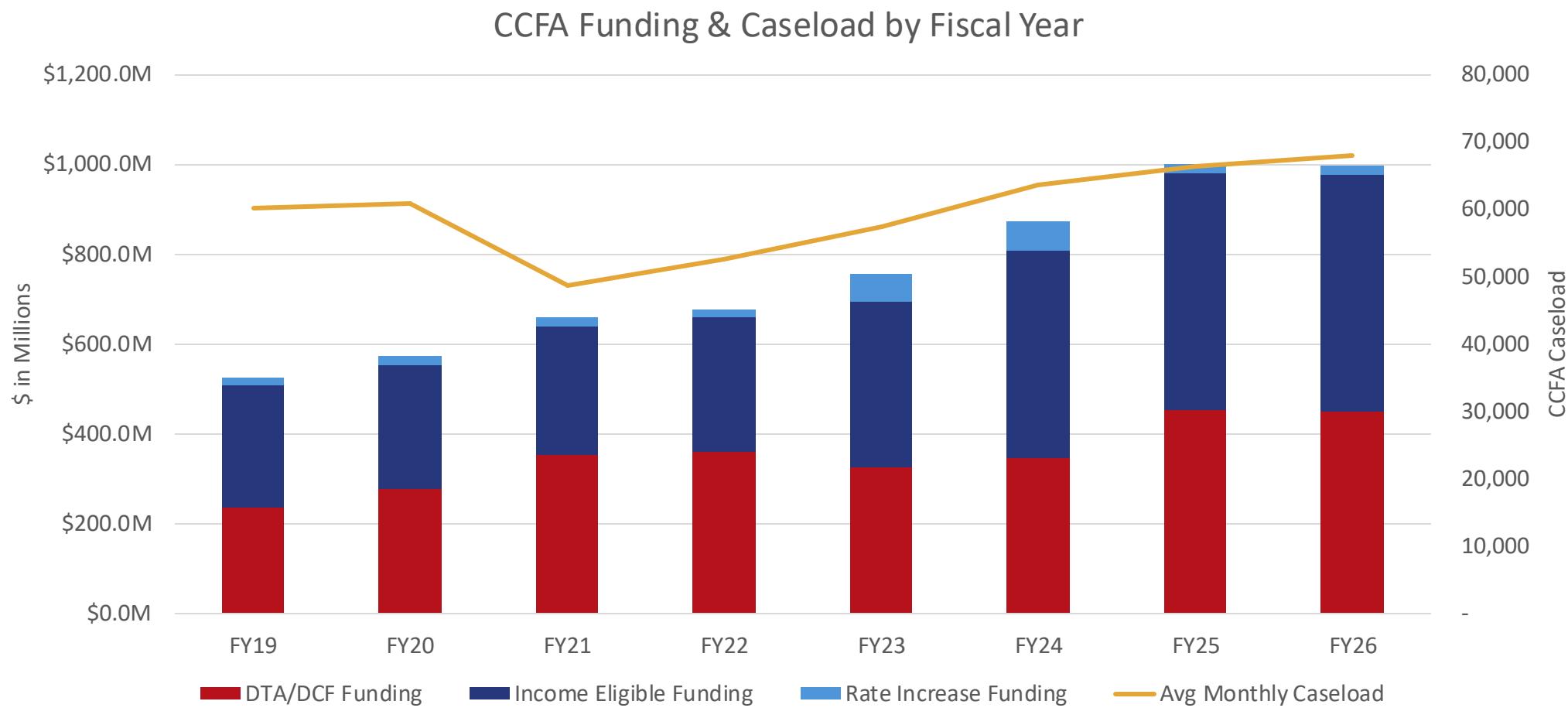
## Consistent and much needed CCFA rate increases and reforms have also contributed to growth in caseload costs.

- In total, **\$248 million** has been appropriated to increase reimbursement rates since FY2019.
- The average infant rate has more than doubled, with similar average increases across toddler and preschool rates.
- Higher CCFA reimbursement rates mean additional funds for program operations, which includes salary increases, and expanded options for families.
- Serving the same number of children the year following a rate increase is more expensive.

# CCFA Rates and # of Children Served

- CCFA rate increases are critical to expanding access for families, supporting program investments in staff salaries and recognizing increases in costs.
- Higher rates also mean that it costs more to serve even the same number of children and families from one year to the next, following a rate increase.
- With the Commonwealth serving more children and families than ever before, at higher rates, \$20 million will not go as far as it would have in past years.

# FY26 Rate Increase

## GUIDING PRIORITIES



**Continue to make data-driven decisions** that focus on both the cost of care and tuition prices



Recognize that **costs are increasing for all programs** through an adjustment to all rates



Continue to pay attention to **geographic equity** and the rates in regions furthest from the cost of care



Support **program operations** and promote **family access and affordability**



**Continue to make incremental progress** toward covering the cost of care

# FY26 CCFA Rate Increase

## ASSUMPTIONS AND CONSIDERATIONS

- **\$20M** for rate increases represents roughly 2% of current caseload spending.
- EEC will **maintain existing regional alignment** of rates this year
  - Western, Central, Southeast
  - Metro Boston, Boston
  - Northeast
- Preschool rates and tuition often **cross subsidize or offset** the higher cost of infant and toddler care for both programs and families.
- FCC cost of care targets are based on center-based director salaries, which is generally **aspirational**, whereas center-based cost targets are based on average **current** salary levels.
- FY26 proposed rate increase is within the context of a **longer-term multi-lever funding strategy** to support incrementally reaching the goal of rates that are at or closer to the cost of care.

# FY26 CCFA Rate Increase: Components

## Across-the-Board (ATB) Increase

ATB adjustments apply a standard percent increase across all rate types for all CCFA providers.

### Benefits:

- All rates get an increase, recognizing the increase in costs facing all programs.

### Constraints:

- Resources are spread out evenly and do not target rates for cost of care or tuition prices.
- The nominal degree of increase is greater for rates that are already higher.

## Cost-of-Care Focused Increases

Focused adjustments apply increases based on the cost of care with consideration to tuition prices.

### Benefits:

- Data-driven strategy that focuses resources on rates furthest from the cost of care.

### Constraints:

- Limited funding requires prioritizing certain rates to get an additional adjustment above the ATB.

# FY25 Current Daily CCFA Rates

- Infant and toddler rates in the Northeast and Southeast are furthest from the cost of care for those age groups (75 percent of cost of care).
- Preschool rates in the Northeast and Southeast are now below 100 percent of the cost of care.
- FCC Over Age 2 rates in the Northeast and Metro Boston are furthest from the cost of care; the FCC Under Age 2 rate in the Northeast is significantly farther from the cost of care compared to other regions.

# FY26 Center-based Rates (Proposed)

ACROSS-THE-BOARD INCREASE + FOCUSED COST-OF-CARE ADJUSTMENTS

- All rates receive an 0.5% (on average \$0.40 per day) ATB increase.
- Additional cost-of-care adjustments are focused on preschool rates that have fallen below the cost of care and the Northeast toddler rate to bring it closer to median tuition prices.
- Adjustments recognize recent investments in infant and toddler rates and important market dynamics such as “smoothing” tuition prices across ages to offset the cost to provide infant and toddler care for programs and families.

# FY26 FCC Rates (Proposed)

## ACROSS-THE-BOARD INCREASE + FOCUSED COST-OF-CARE ADJUSTMENTS

- All rates receive an 0.5% (\$0.40 average) ATB increase.
- Additional cost-of-care adjustments are focused on FCC Over Age 2 rates that are furthest from the cost of care and the Northeast Under Age 2 rate to bring it more in line with similar cost regions.
- Finite resources limit the extent to which the gap between Over and Under Age 2 rates can be closed.

- EEC will continue to research and focus on the cost of care and how multiple funding mechanisms (e.g., CCFA rates and C3) help fill program revenue-expense gaps and support additional investment.
- With this broader knowledge of system and program financing, EEC plans to develop a multi-year resource strategy including and not limited to cost of care targets for CCFA rates.

# Commonwealth Cares for Children (C3)

## FY26 UPDATES

### FY26 APPLICATION UPDATE

- Recalculated monthly grant amounts based on November 2025 inputs
- Per statutory requirement, introduced new attestation regarding willingness to enroll children with CCFA
- As of 12/7, 46 (15 center-based and 31 family child care) programs have attested “No” and unenrolled from C3
- Will launch technical assistance supporting allocation of 50% of C3 funds to workforce related expenses

### JANUARY 2026

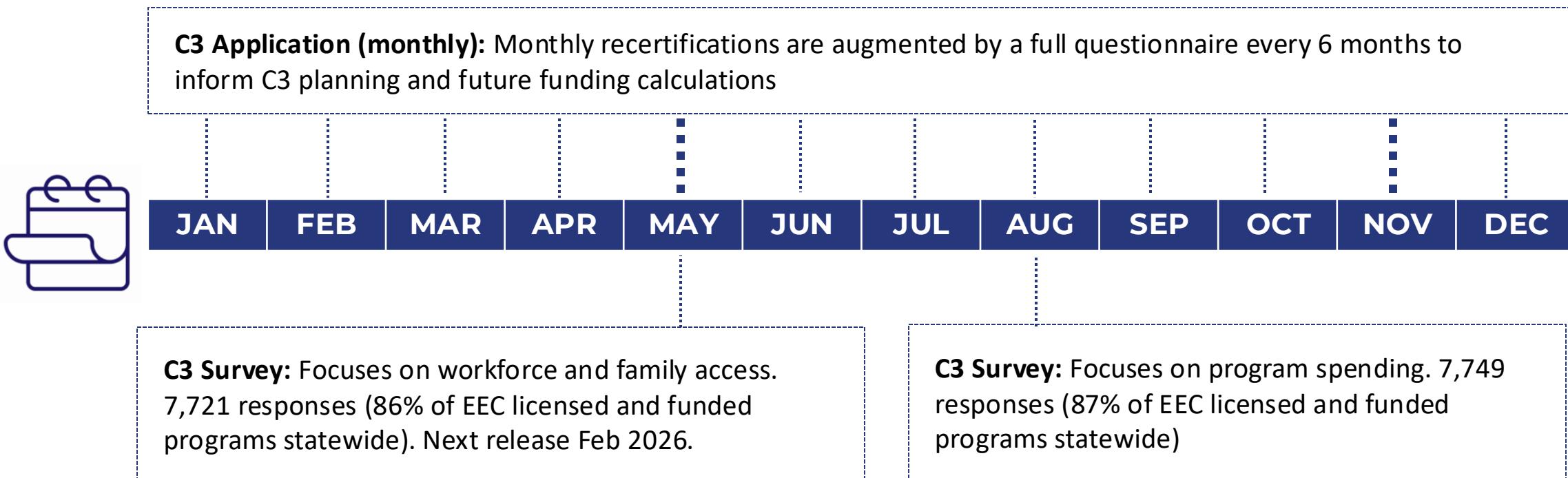
- Conduct fiscal assessment re: cost to enable new programs to participate in C3.
- Since July 2025, 600 newly opened programs not accessing C3

### FY27 PLANNING

Ongoing discussions with the Board and stakeholders on the C3 formula and draft proposed regulations (under development)

# Data Collection: C3 Application and Survey

- C3 application and survey provide predictable cadence for data collection from participating programs through point-in-time data collection.



- **Impact:** Provides regular information to support future costing, ongoing analysis of C3 impact and planning

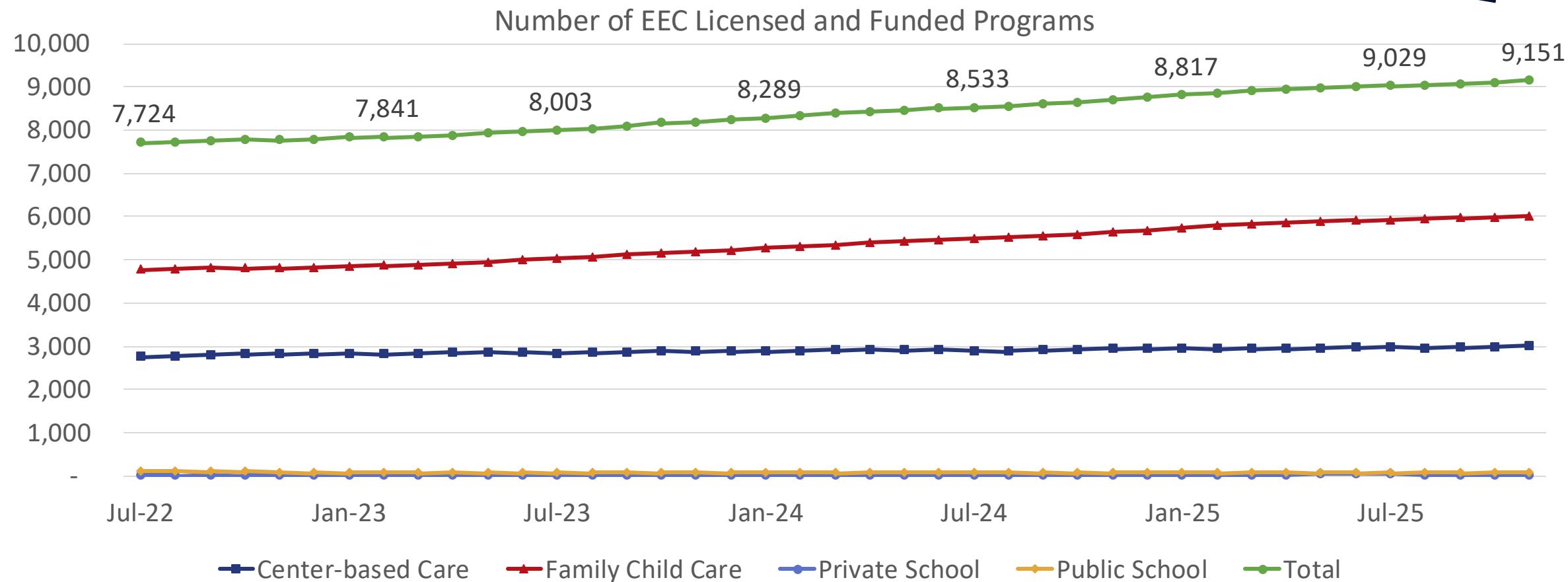

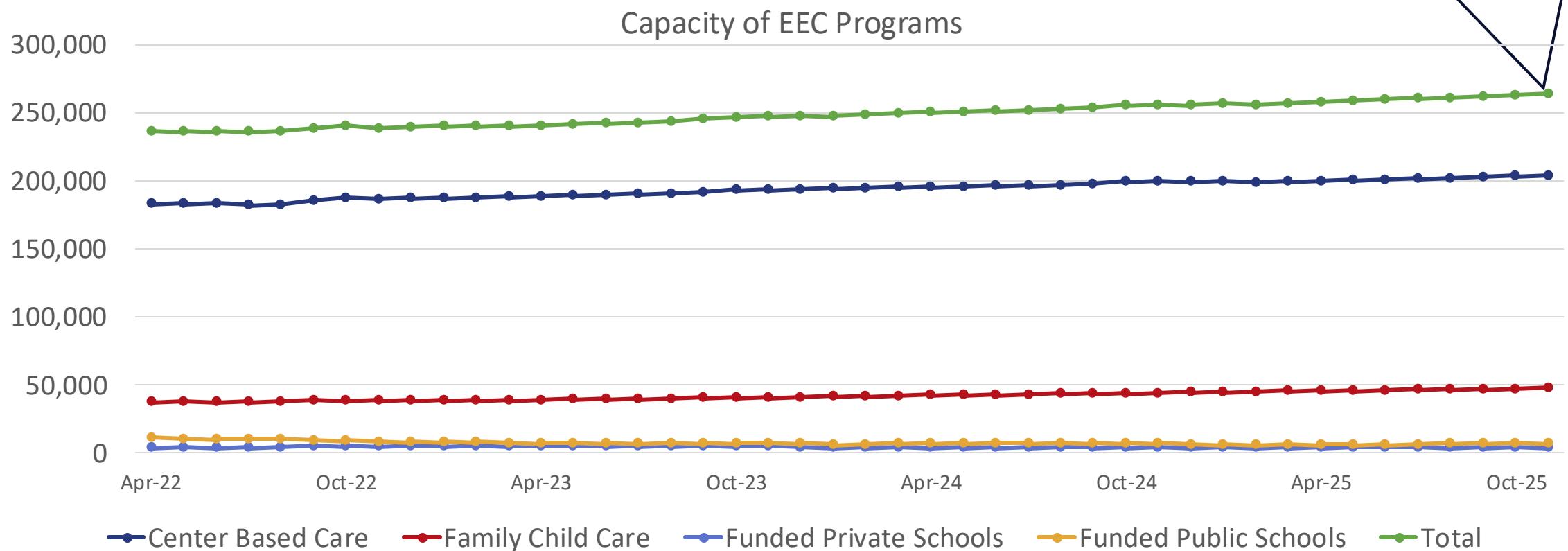

# The number of early education and care programs statewide continues to grow.

There were 451 more EEC licensed and funded programs in Nov 2025 compared to Nov 2024.



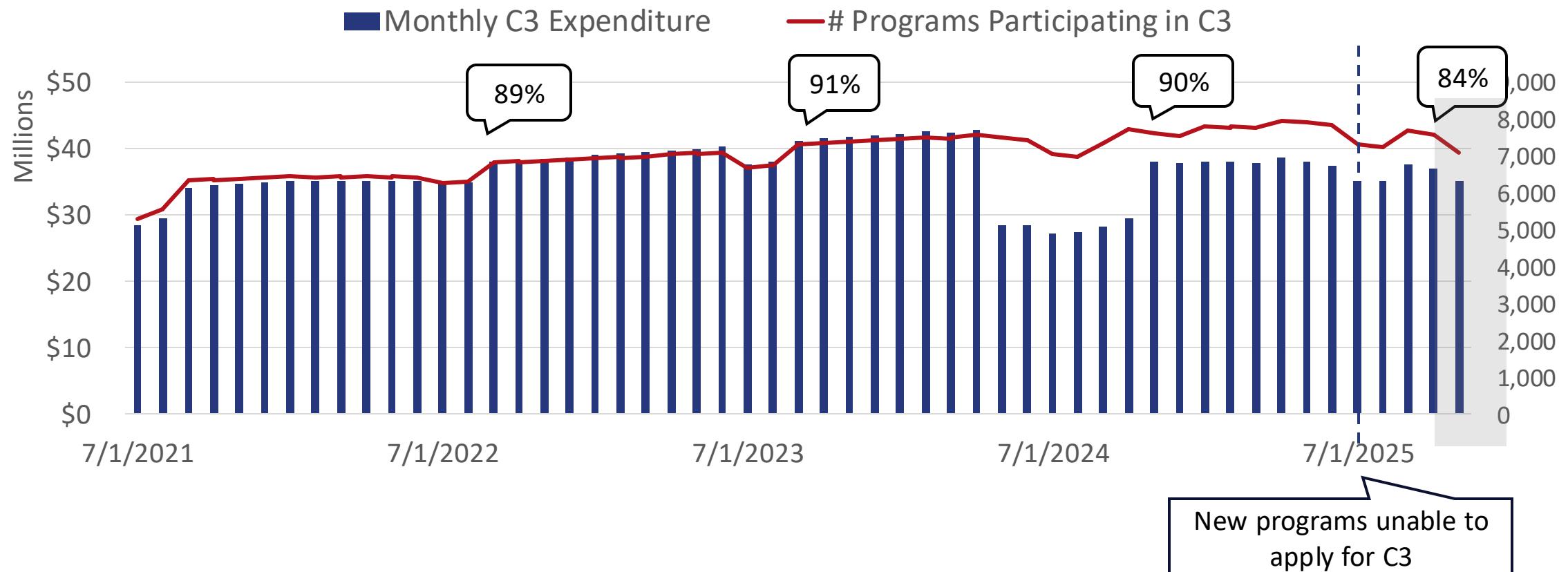
# That same growth is seen in total capacity of early education and care programs, making more seats available for children and families.



There were 7,658 more EEC licensed and funded seats in Nov 2025 compared to Nov 2024.

# Growth in programs is outpacing the availability of C3 funds

C3 program participation "declines" 6 percentage points, as new programs open but are not accessing C3 funds.

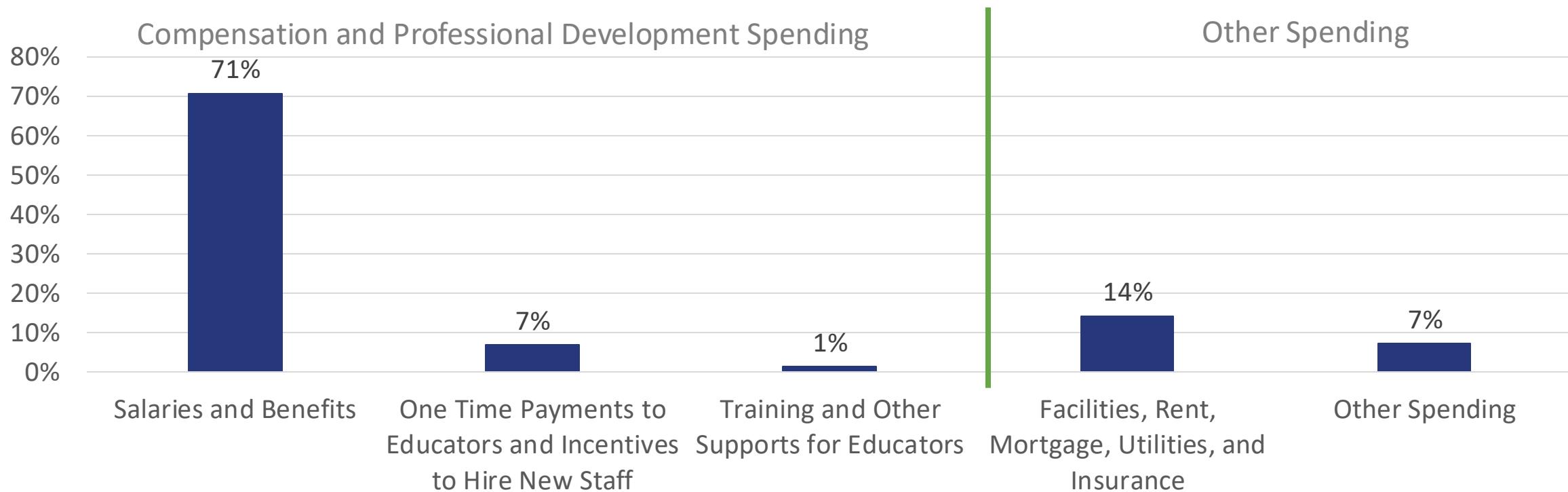

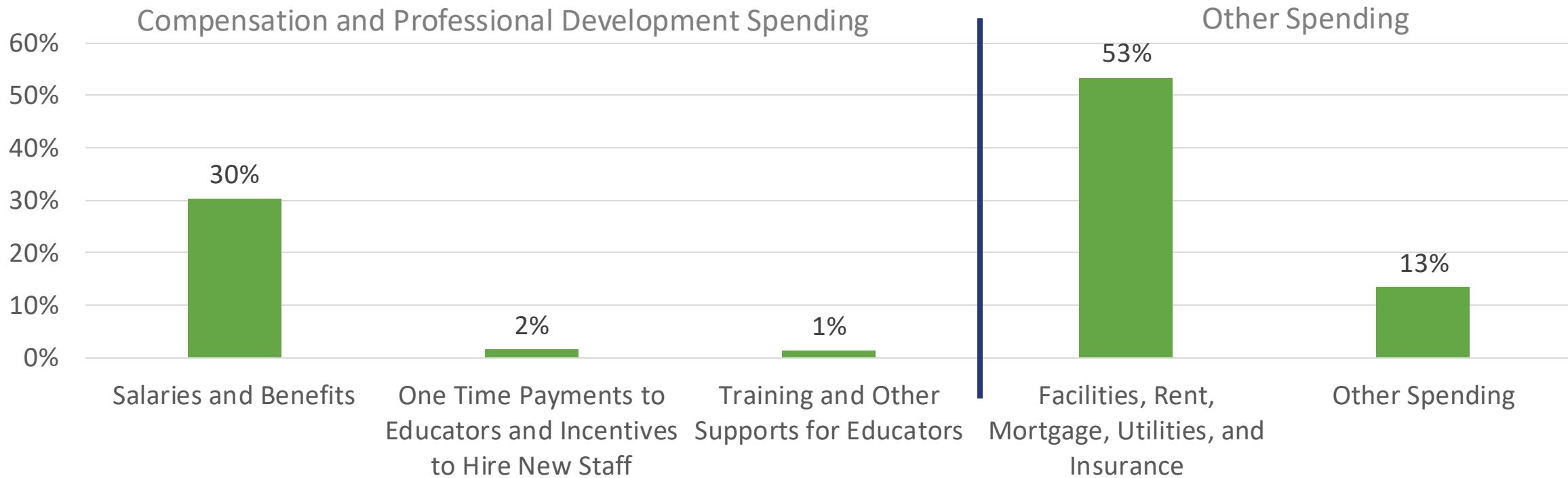
# Overall, centers spent almost 80% of C3 funds on workforce related expenses in FY25

Center Based FY25 C3 Spending, by Category

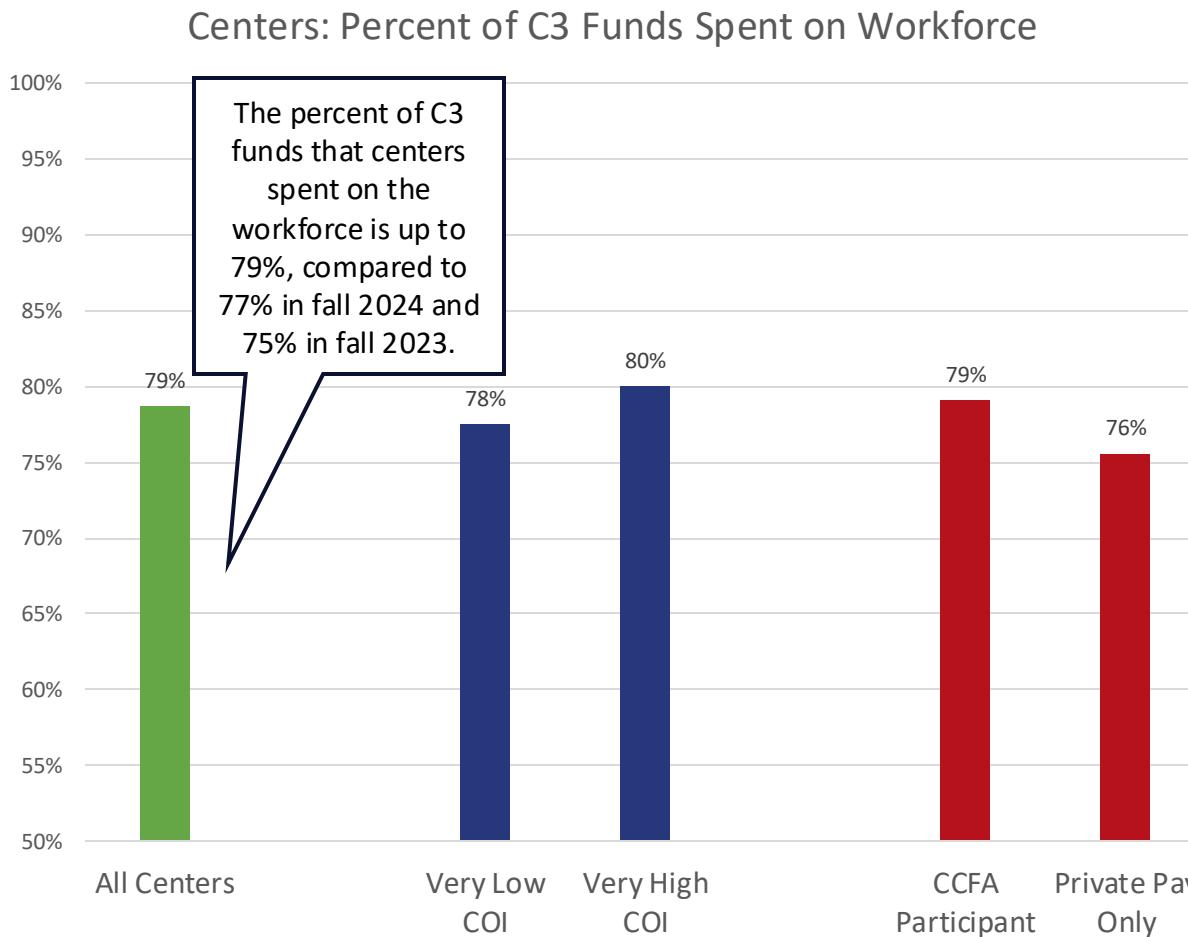


# FCCs spent almost 90% of C3 funds on compensation, professional development, and occupancy related expenses in FY25

Family Child Care FY25 C3 Spending, by Category



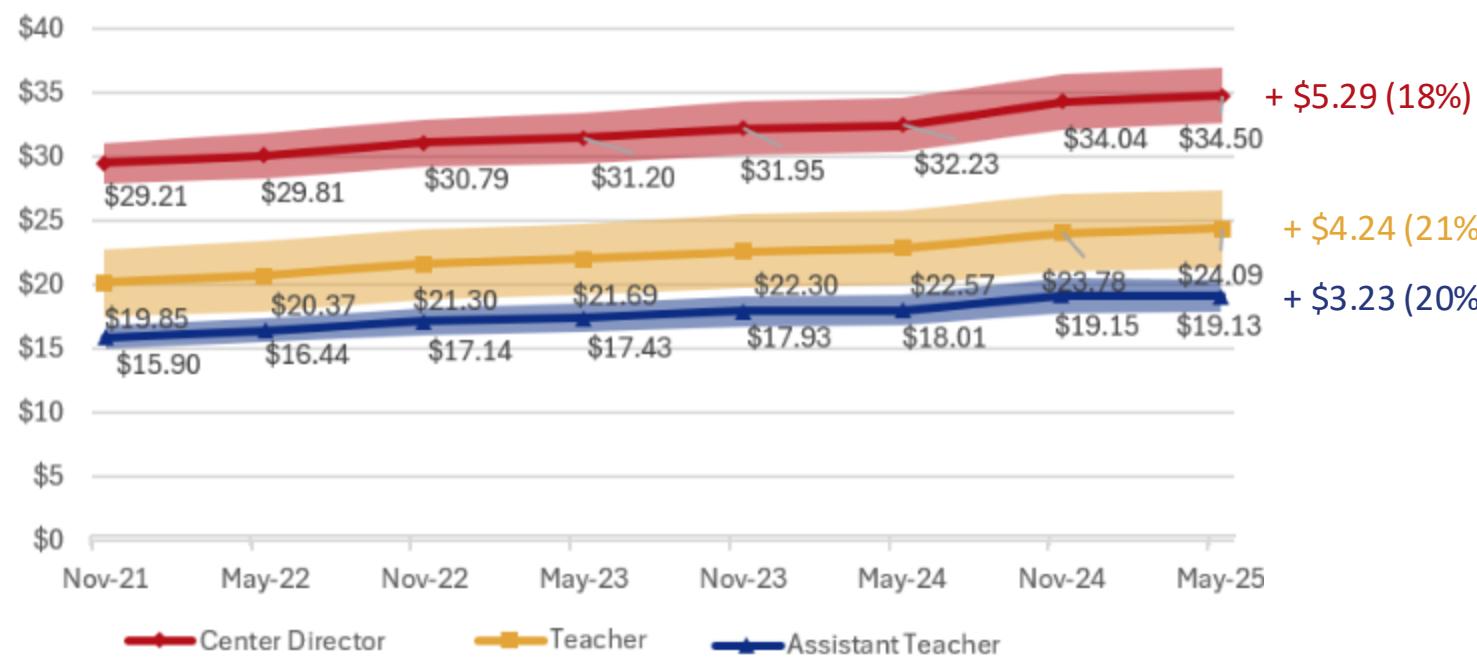
# Centers spent a substantial proportion of C3 funds on workforce compensation in FY25



- Overall, centers spent 79% of FY25 C3 funds on the workforce.
- 80% of centers spent at least half of their C3 funds on the workforce.
- Of the 2,333 centers (85%) that spent at least some C3 dollars on educator/staff salaries, 1,857 (80%) used these funds to raise wages.

# Educator wages are growing but remain low, especially when accounting for inflation

Average Hourly Wages – Center Based Early Education (Ages 0-5)



C3 data show an increase of more than \$4 per hour in the average wage of a center-based educator in Massachusetts since the inception of the C3 program in 2021.

Analysis conducted by Boston University's Wheelock Education Policy Center (WEPC) indicates that this increase is equivalent to about \$0.80 per hour after adjusting for inflation.

(Note: Data for school age positions show similar trends and are included in the appendix.)

# Educators continue to leave their roles at high rates, although these rates are decreasing.

The C3 survey allows EEC to calculate a separation rate, or the rate at which educators are leaving the programs in which they are employed.

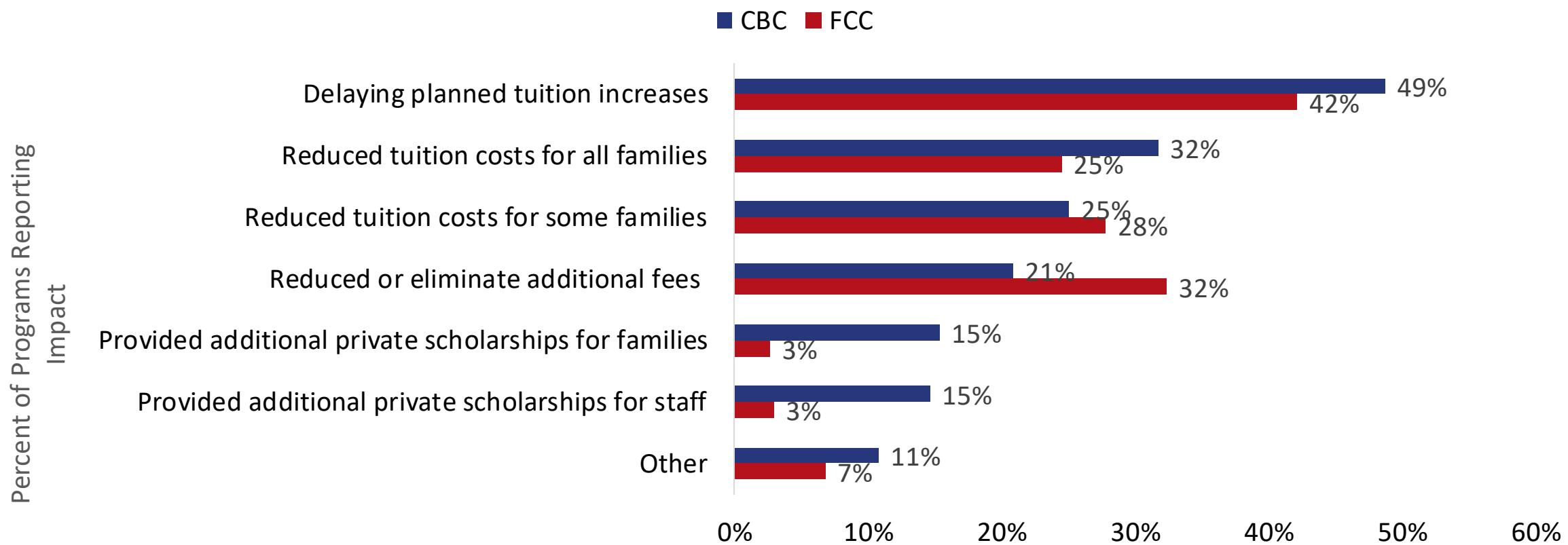

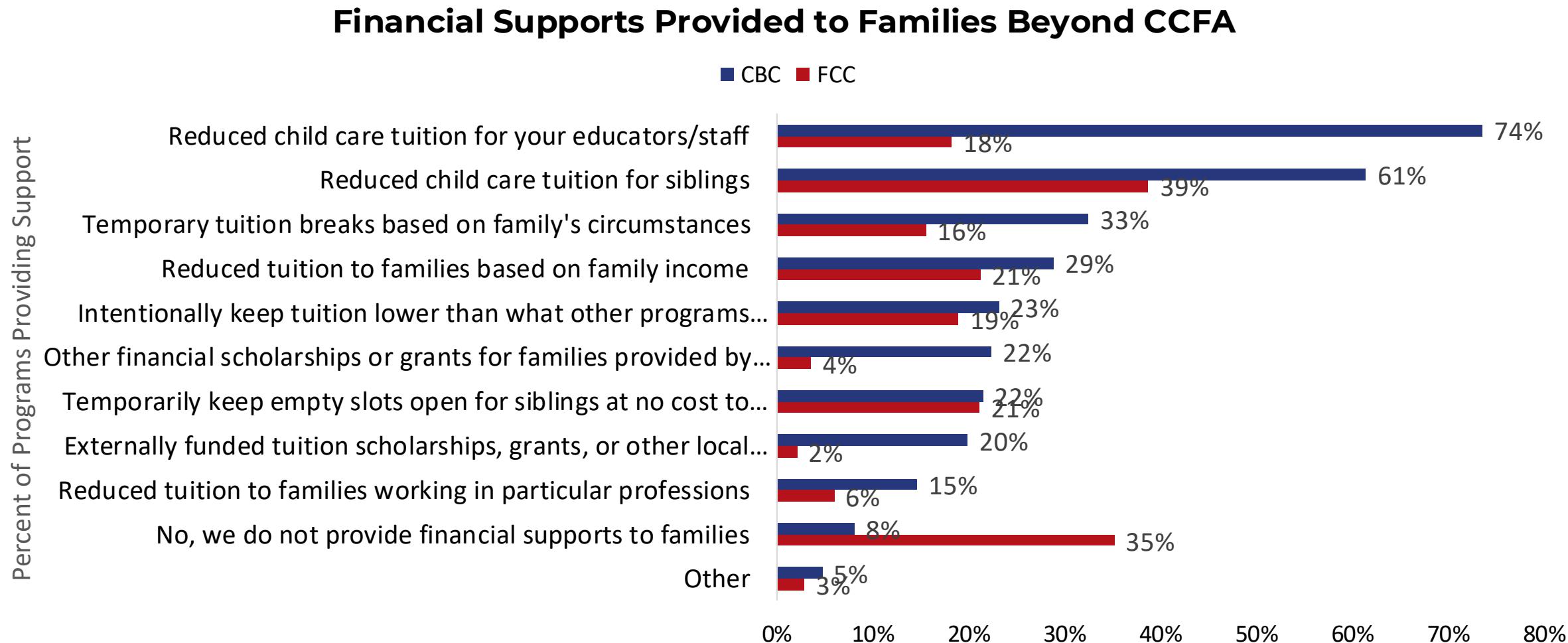

## PROGRAM GOALS AND DESCRIPTION

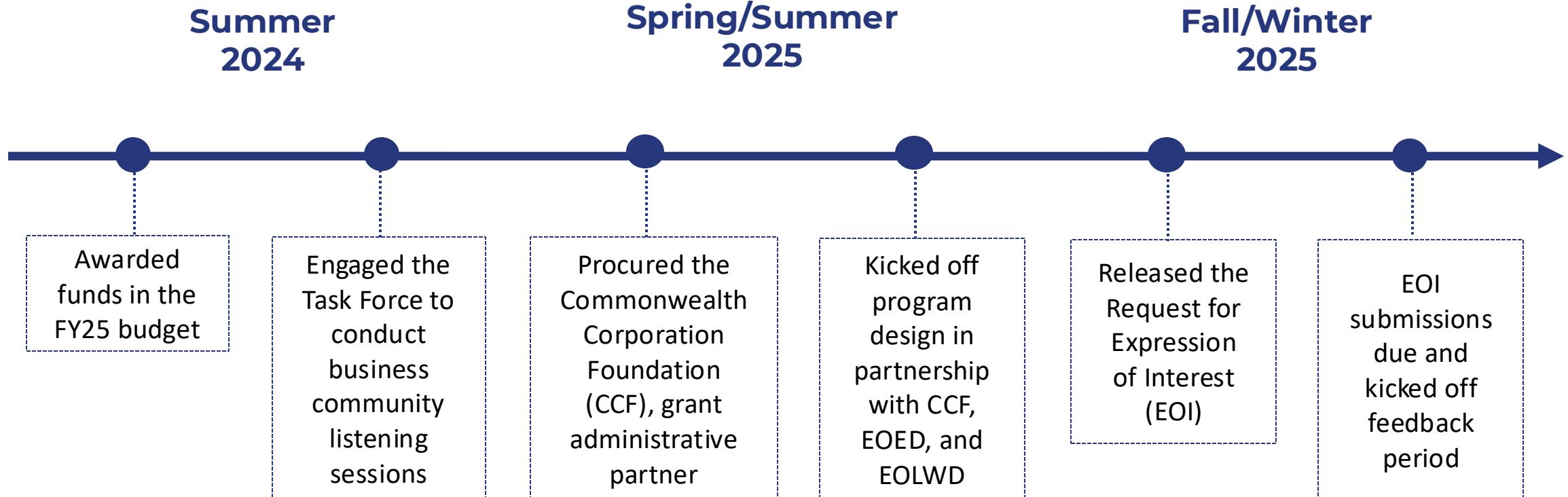
### Program Goals

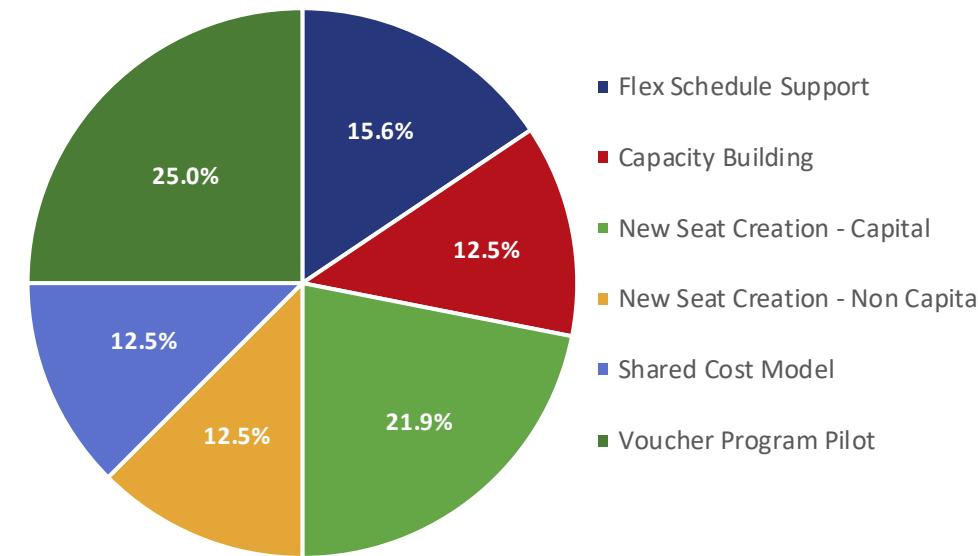

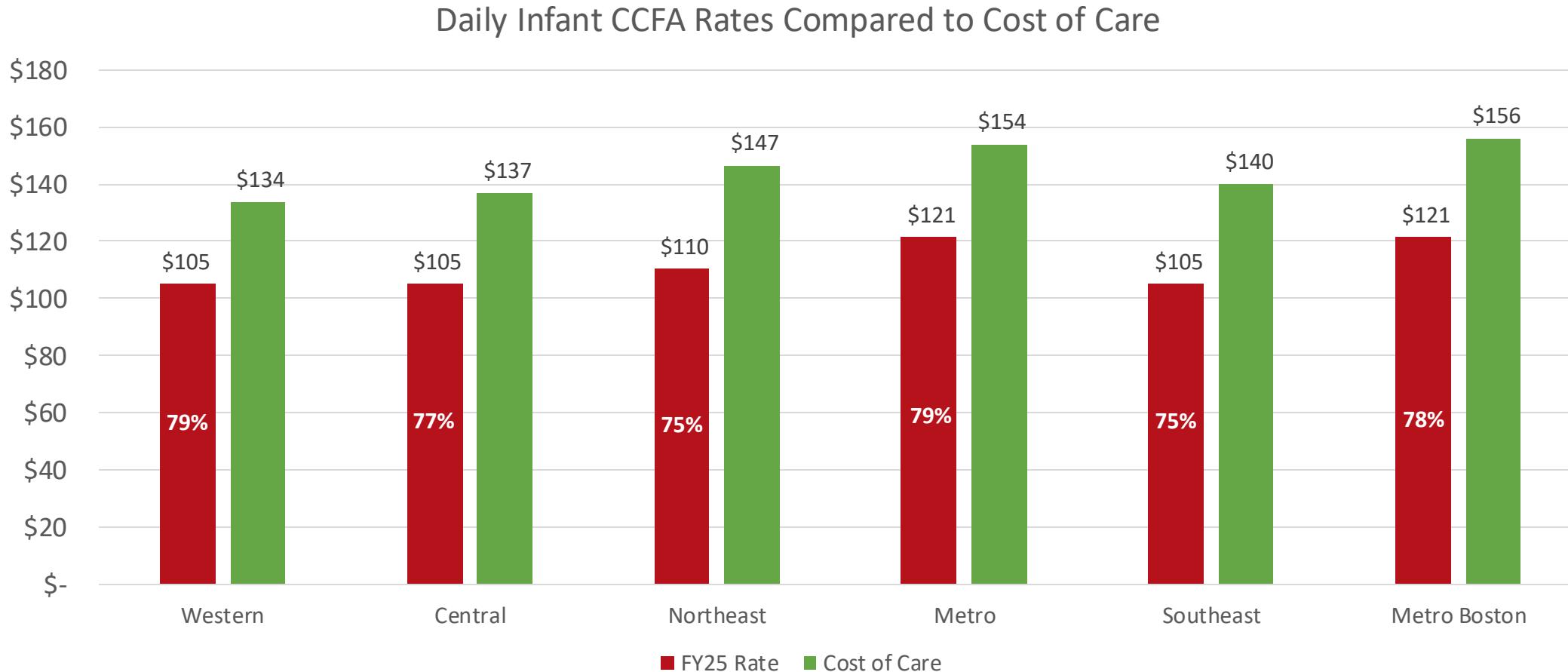

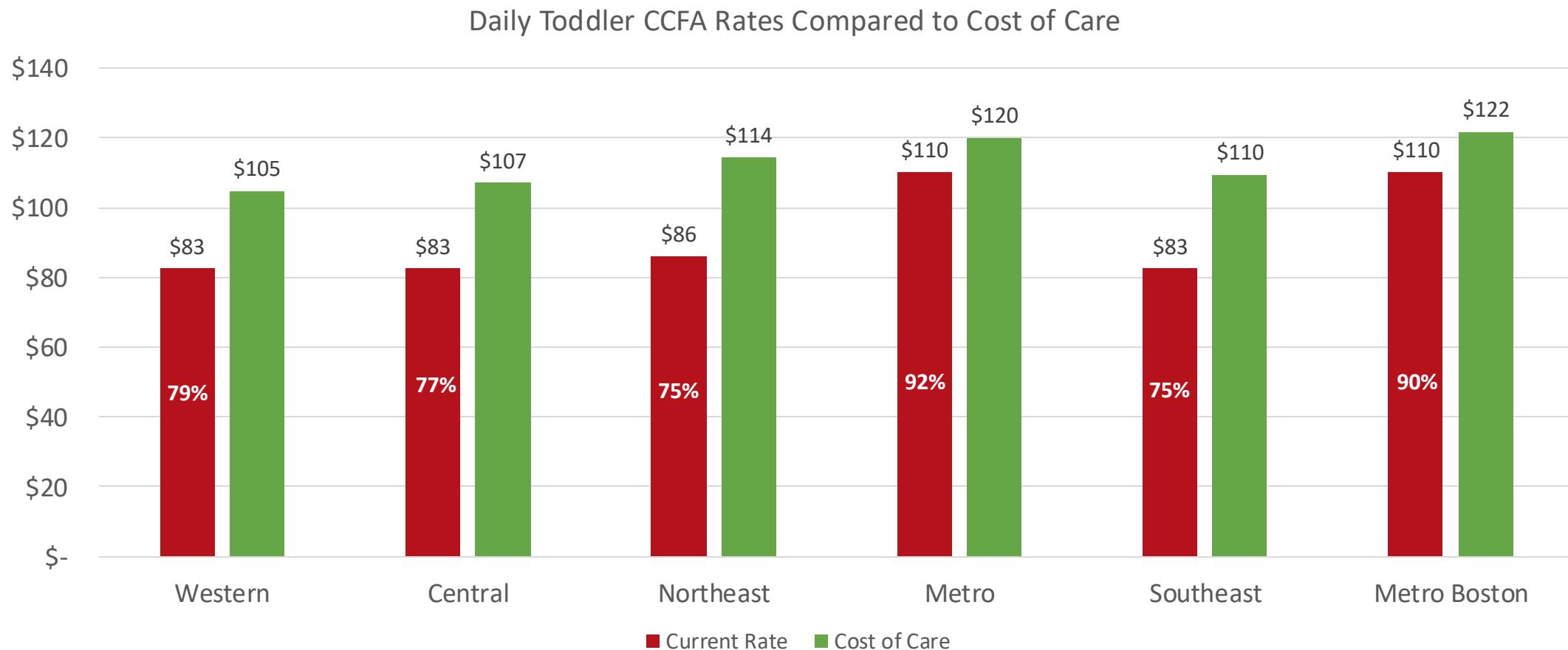

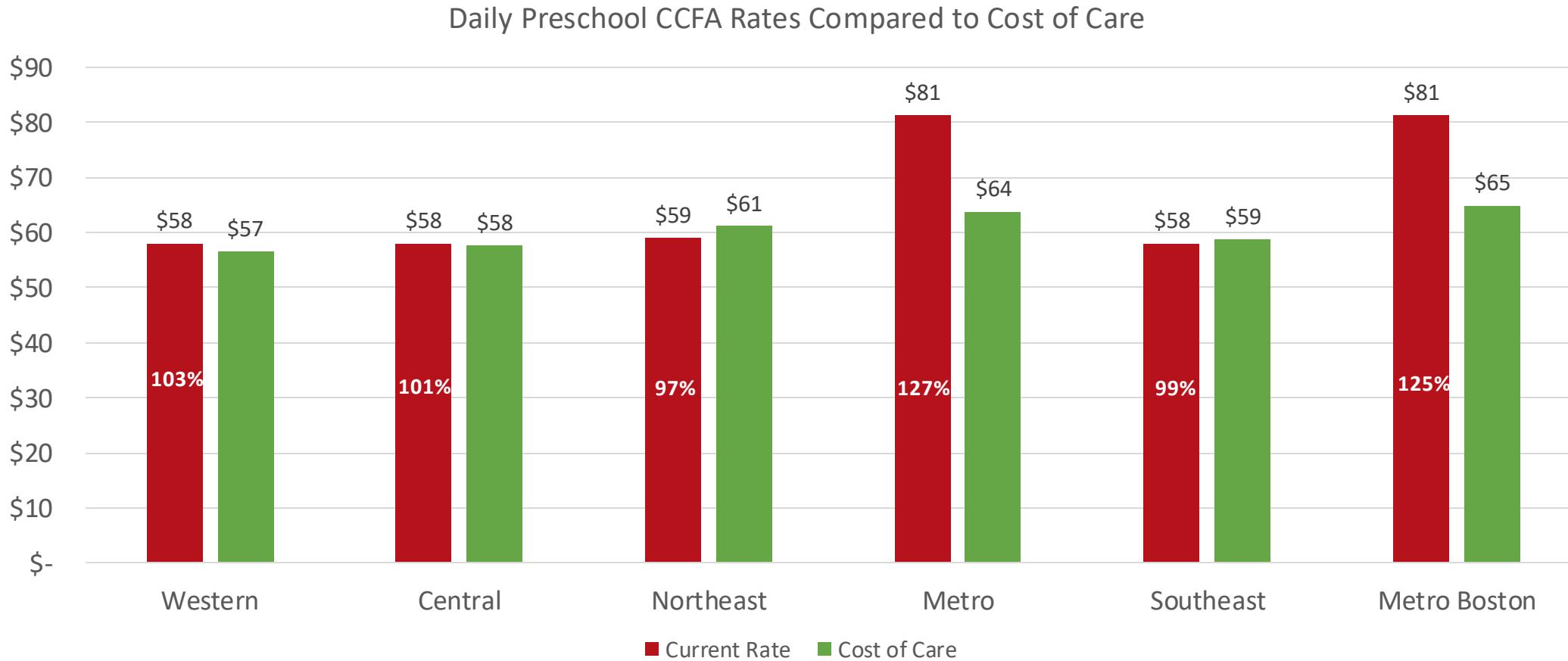
# Center-Based Infant CCFA Rates Compared to the Cost of Care



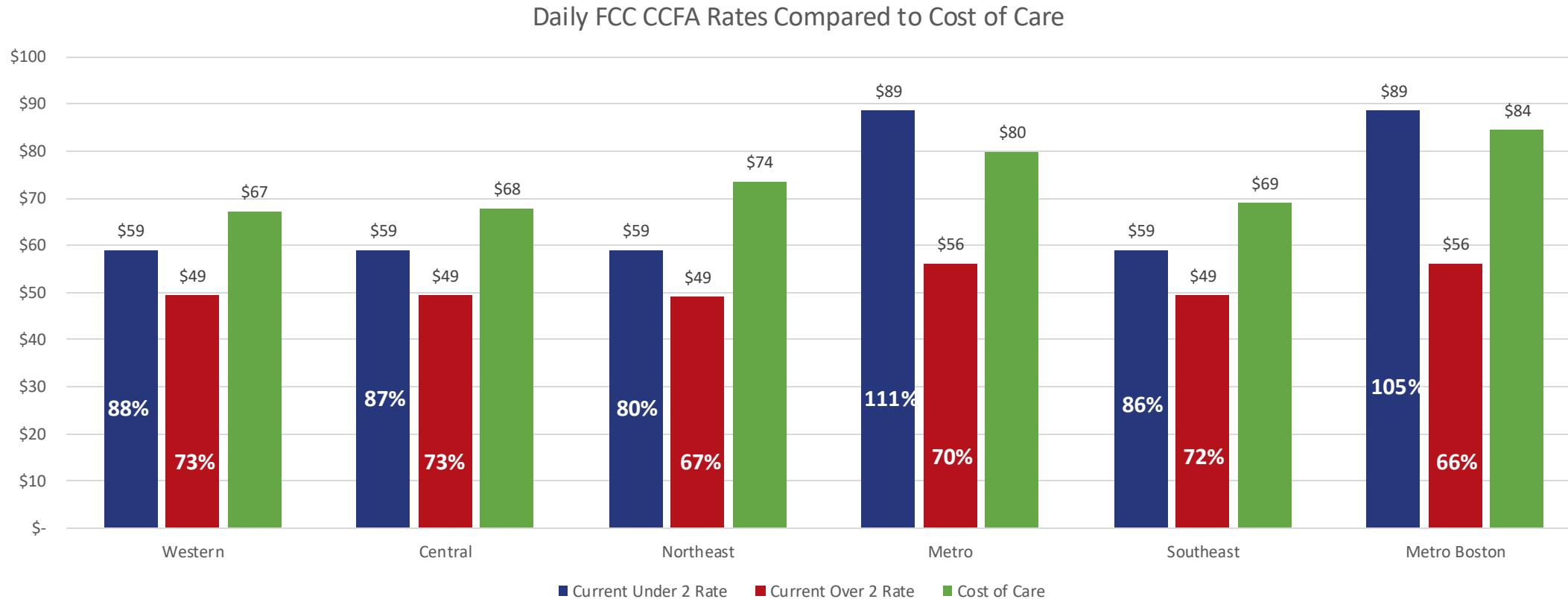
# Center-Based Toddler CCFA Rates Compared to the Cost of Care

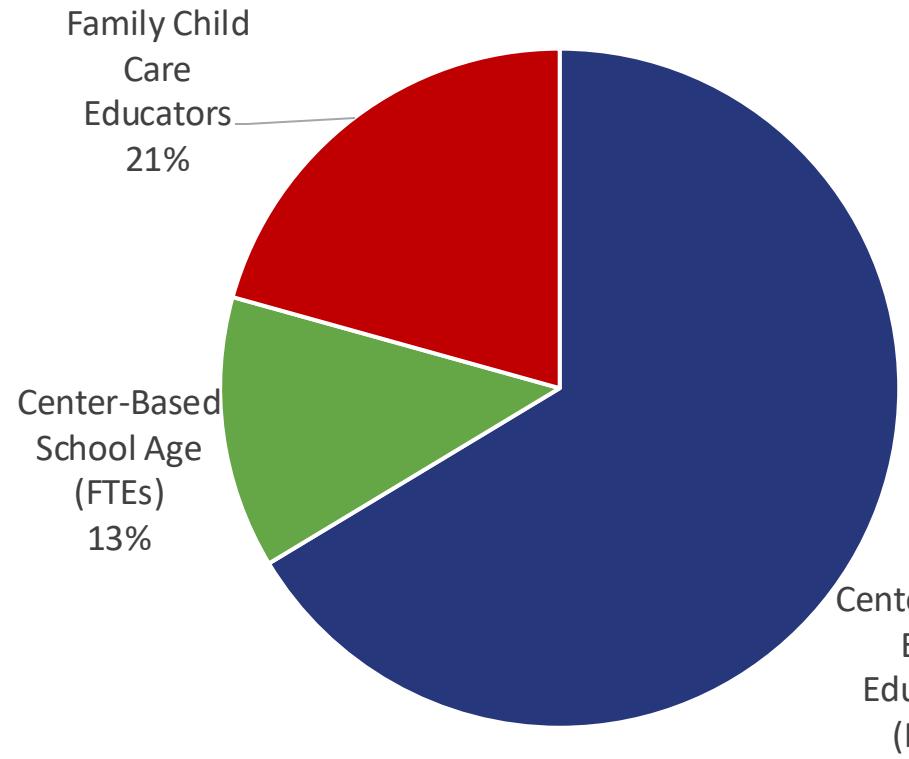

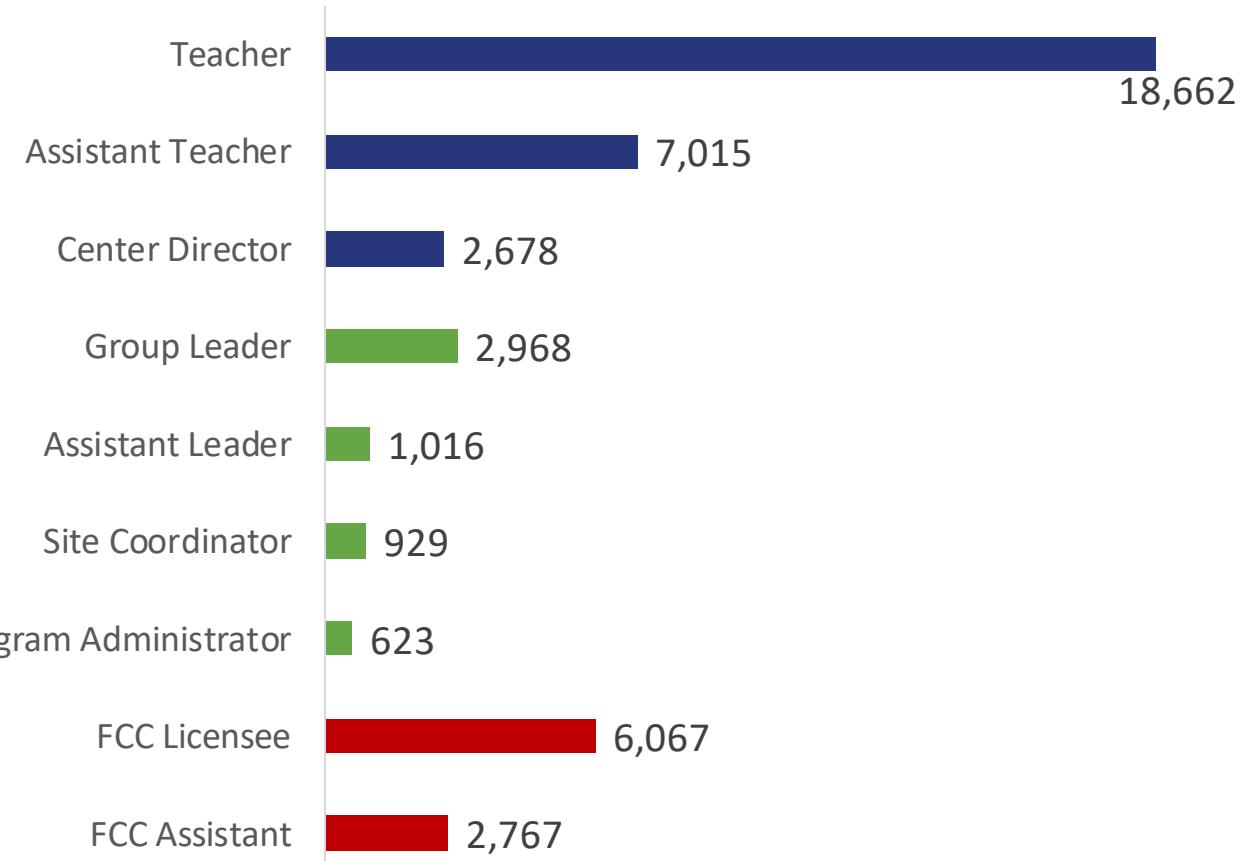

Number of Educators by Program Type

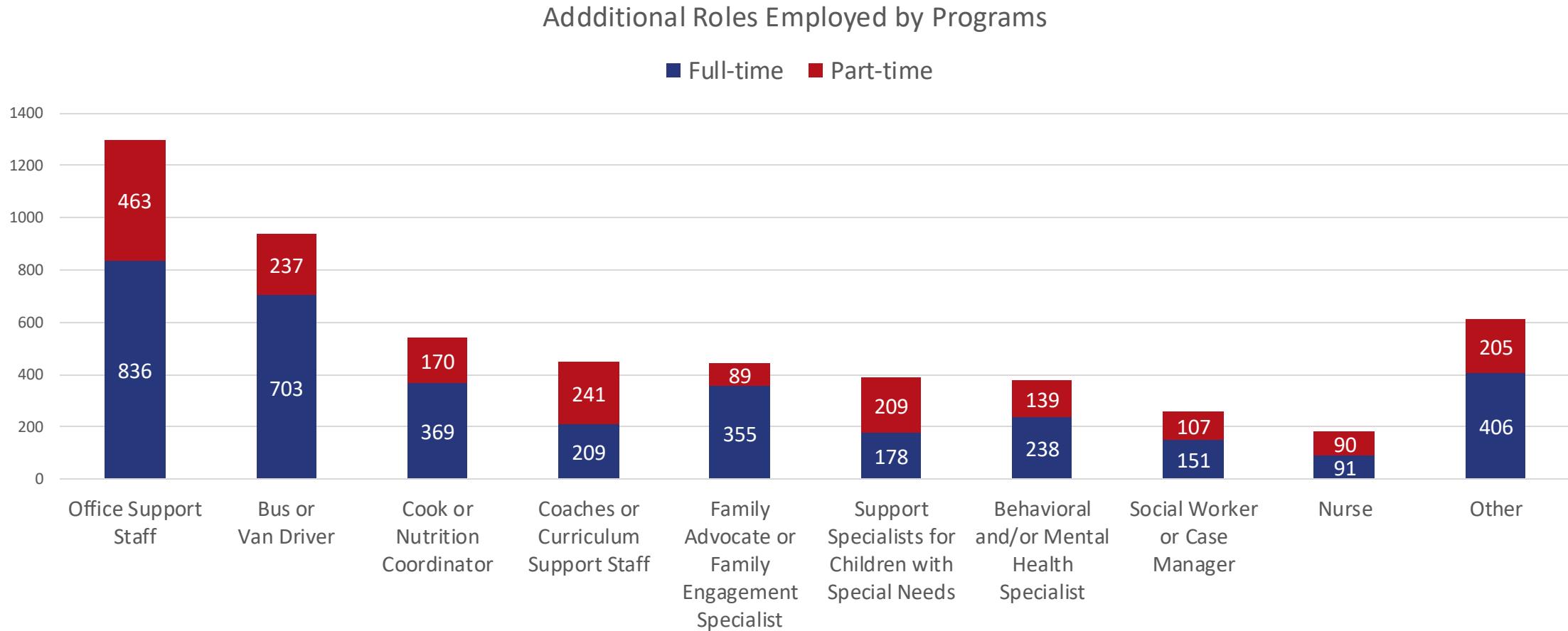

Number of Educators by Job Title



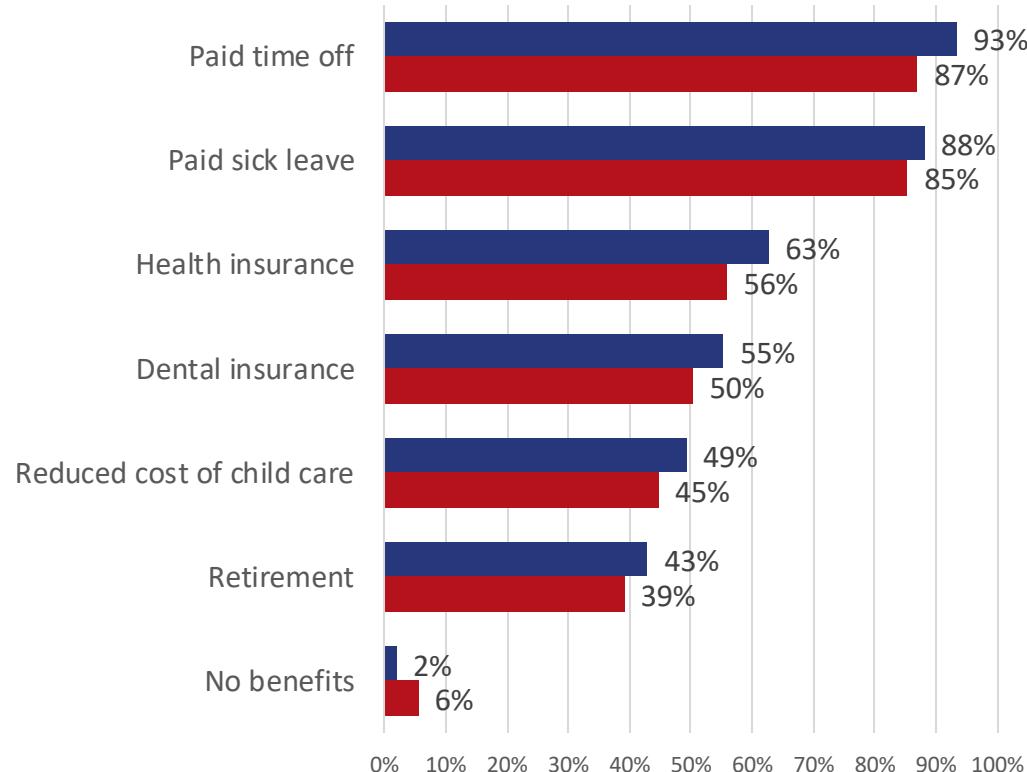

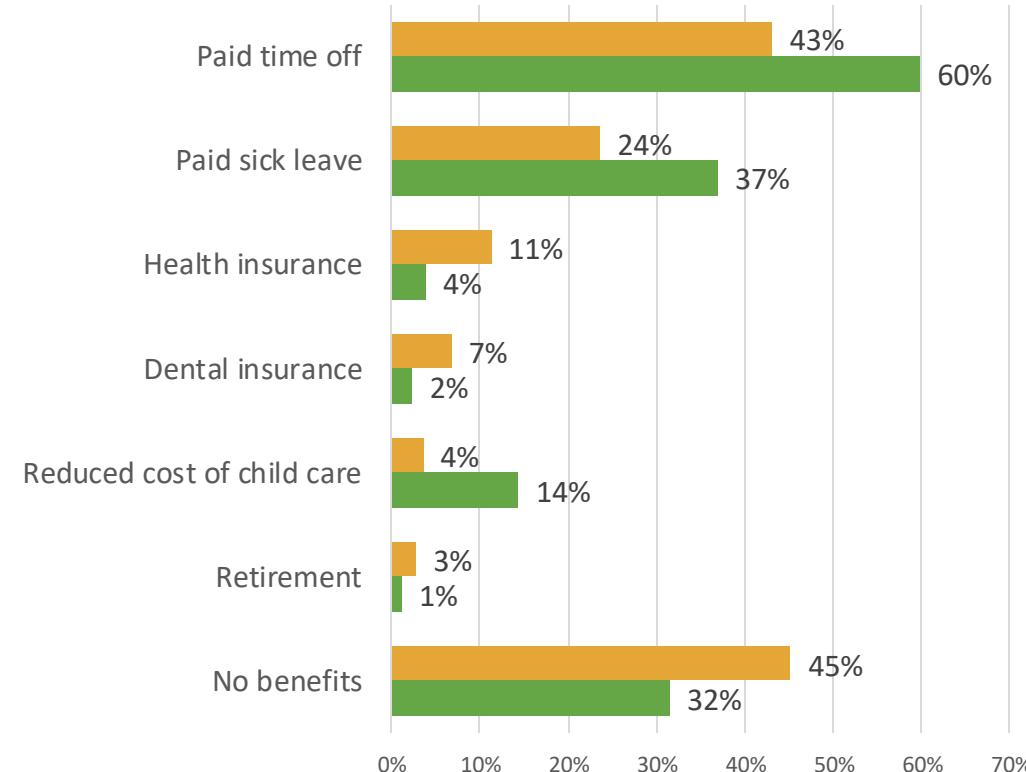
Top Reported Benefits Offered by Job Role: CBC

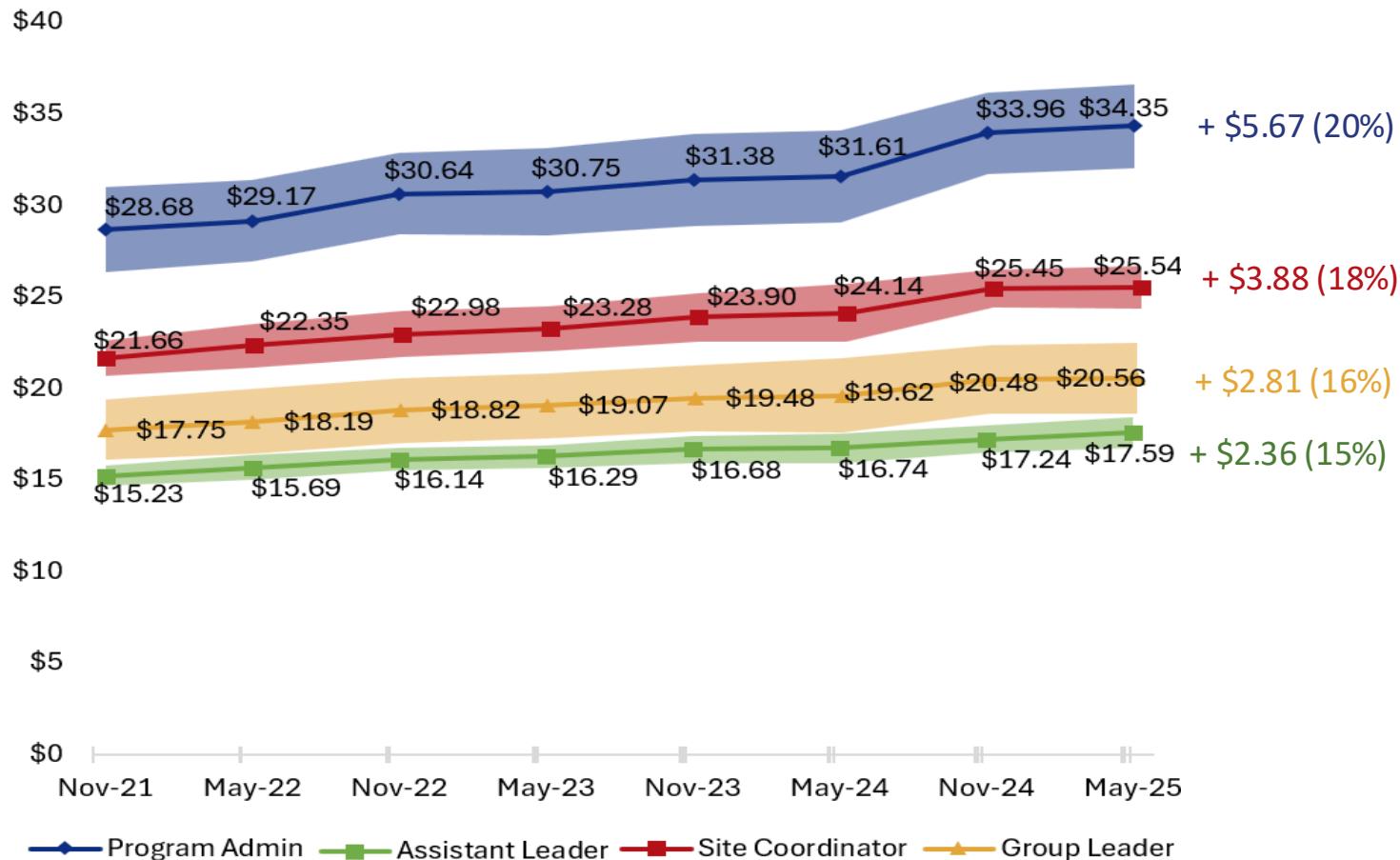

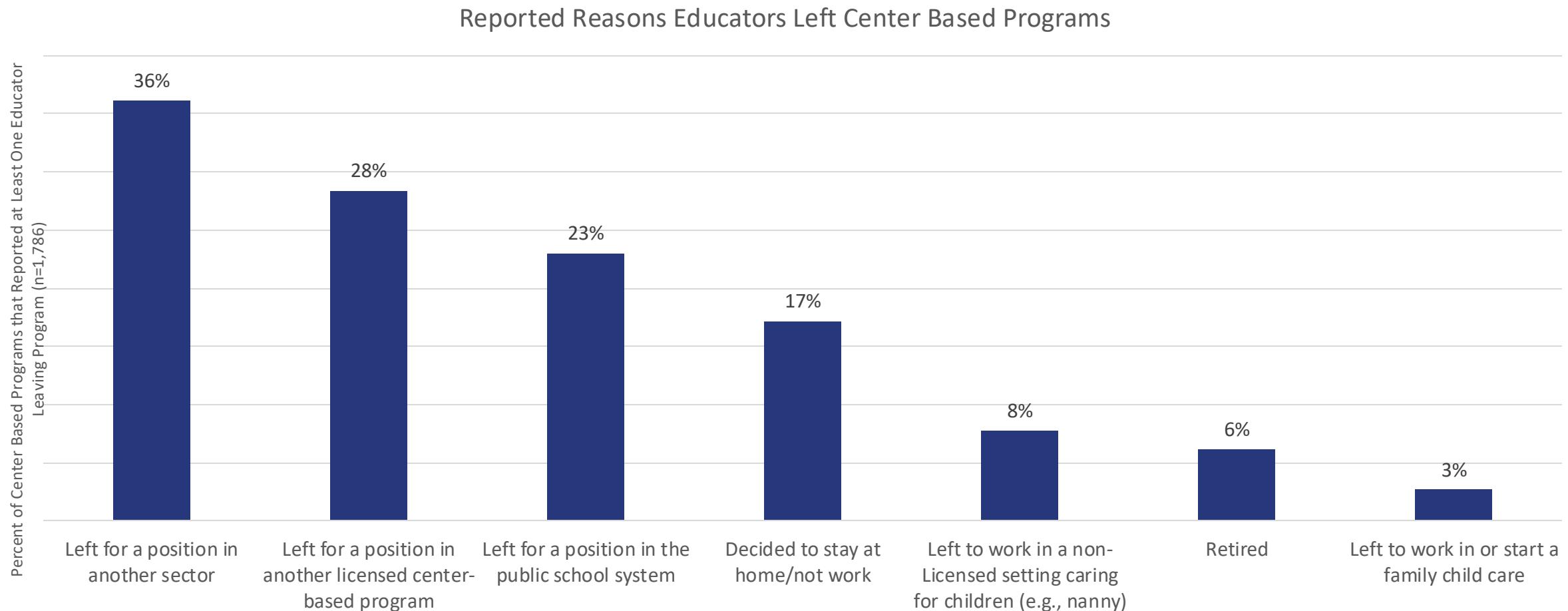

Average Hourly Wages – Center Based (School Age)



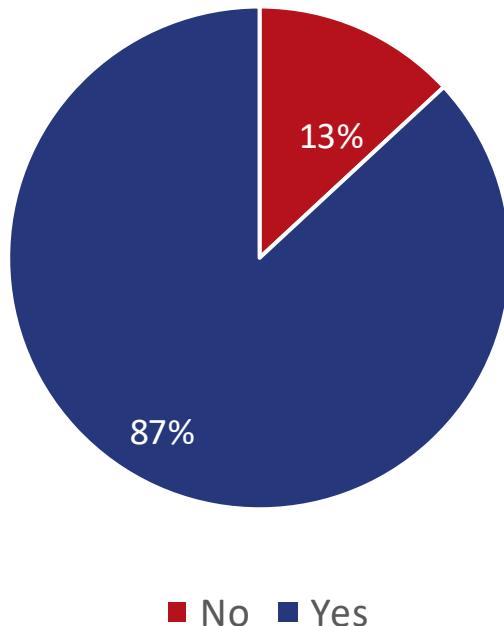

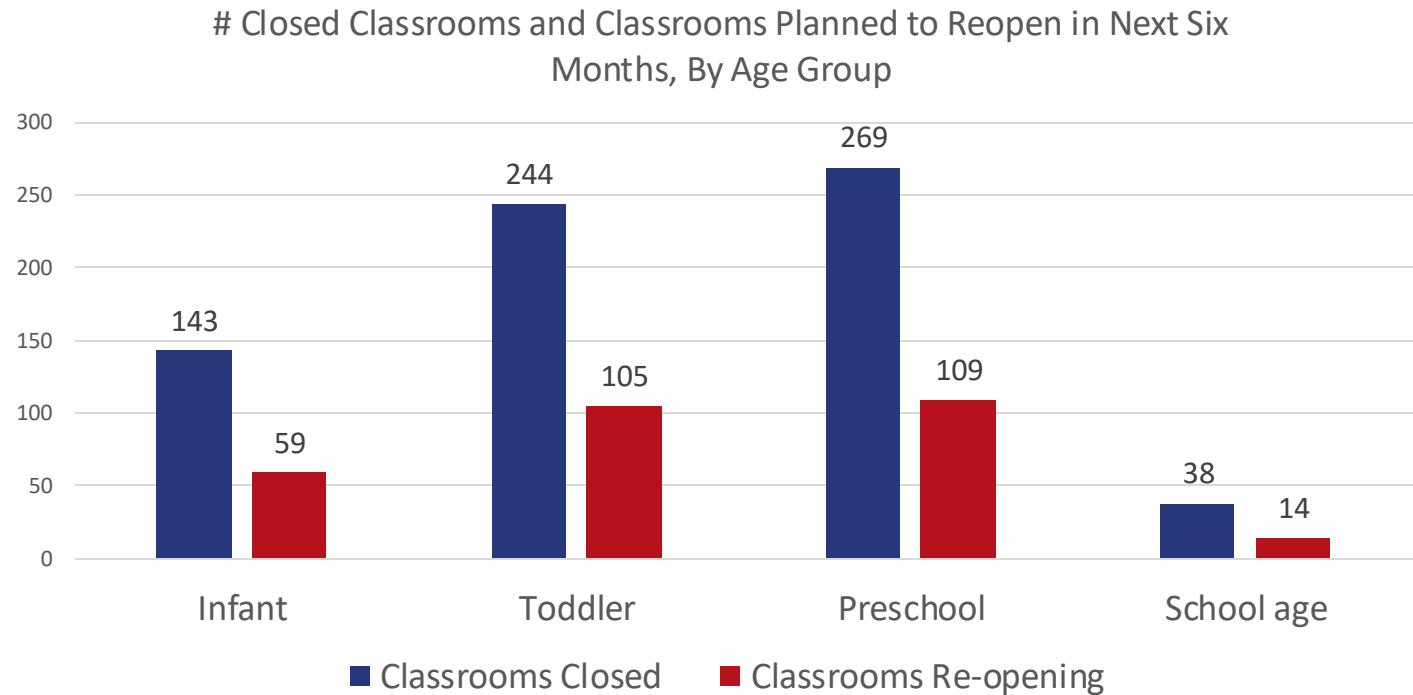

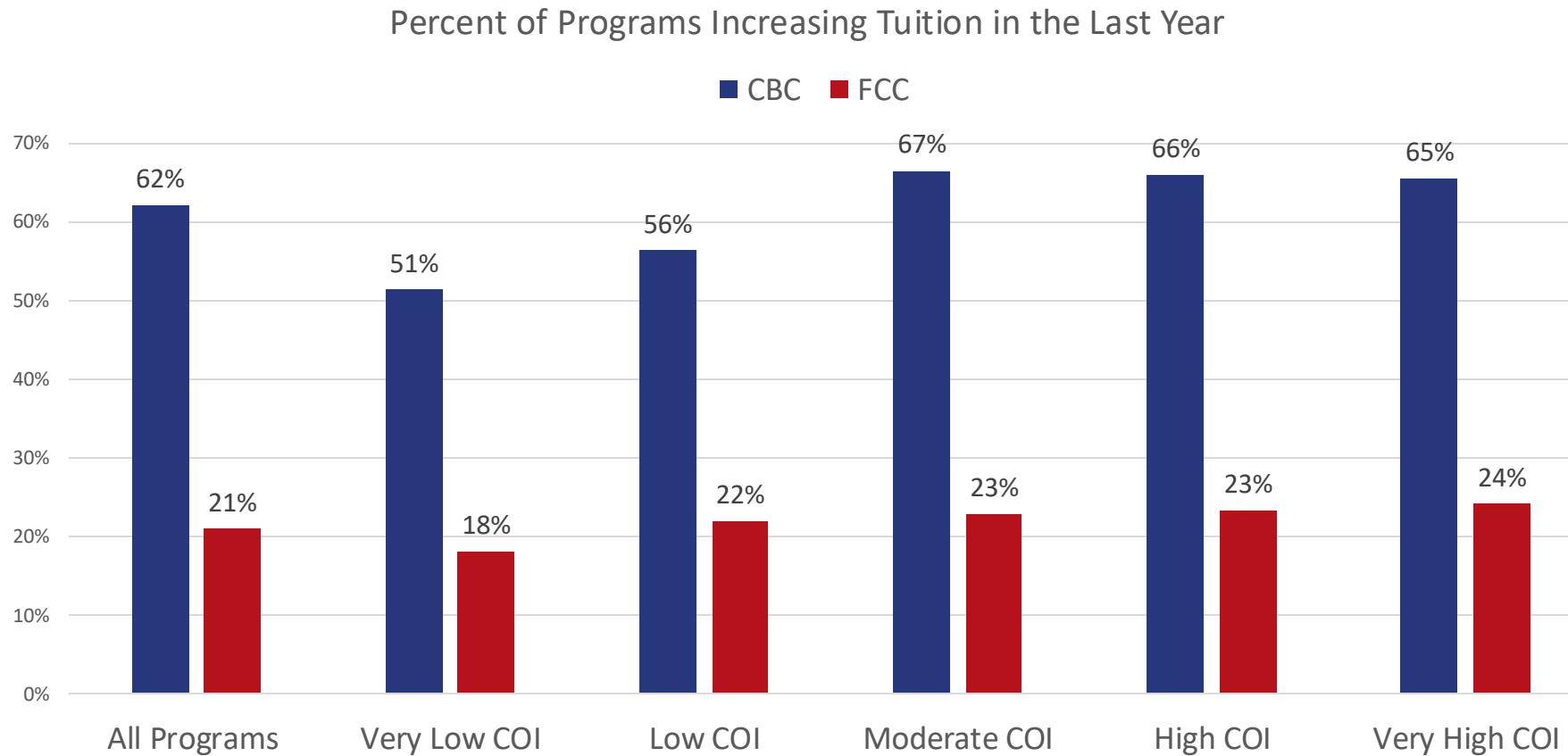
Percent of Programs with Closed Classrooms

# Most center-based programs have raised tuition within the last year, whereas most FCCs have not. More programs have increased tuition in higher COI communities.

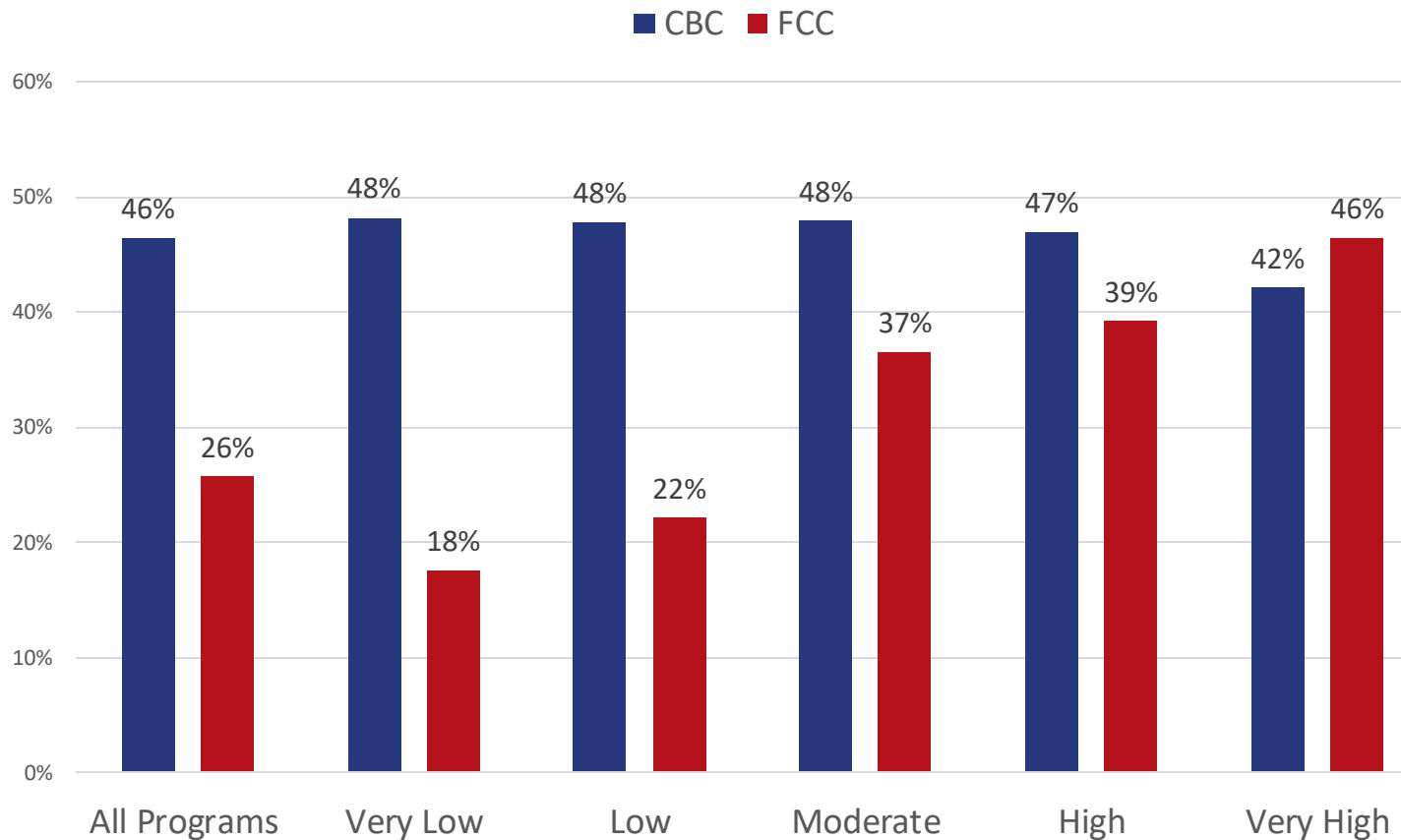


Most programs that report increasing tuition have increased it by less than 5%.
