Objektif MEPA

- **MEPA: Massachusetts Environmental Policy Act/Lwa sou Règleman Anviwònman Massachusetts**
 - MGL c. 30, s. 61 a 62L; 301 CMR 11.00 (règleman)
- **Objektif se etidye enpak anviwònman pwojè yo**
 - Pwojè a dwe fè pi bon efò pou evite oswa minimize domaj anviwònman an
- **Prensip Jistis anviwònman (EJ) aplikab**
 - Nenpòt pwojè ki toupre kominote EJ yo dwe soumèt rapò enpak anviwònman an (EIR), si li oblije ale nan pwosesis MEPA (gade pwochen diapositif la)
 - Dwe abòde nenpòt domaj yo idantifye nan kominote EJ yo
- **MEPA pa apwouve/refize pwojè dirèkteman**



Ki lè revizyon MEPA obligatwa?

(1) Premyèman, pwojè a dwe mande "aksyon" nan men yon ajans:

- Si ajans yo pwopoze pwojè a dirèkteman (sitou ajans leta yo)
- Si pwojè a bezwen pèmi/apwobasyon ajans lan
- Si pwojè a mande finansman oswa tè/pèmi nan men ajans

(2) Dezyèmman, pwojè a dwe enplike yon "kritè revizyon" MEPA:

- Tè, espès ki ra, marekaj, dlo, dlo ize, transpòtasyon, enèji, lè, dechè solid/danjere, resous istorik/akeyolojik, zòn ki gen enkyetid enpòtan pou anviwònman an (ACEC)



Kisa k ap pase pandan revizyon MEPA?

(1) Revizyon "ENF" (Fòmilè Notifikasyon Anviwònman)

- Pwojè ranpli yon premye depoze nan Biwo MEPA (ki rele fòmilè "ENF").
- ENF pibliye nan Environmental Monitor (de fwa/mwa; gade pwochen fichye a).
- Yo pran kòmantè piblik yo pou 20 jou, epi desizyon yo bay nan 10 jou. Desizyon an bay konsèy sou sa yo dwe mete nan EIR la.

(2) Revizyon "EIR" (Rapò Enpak sou Anviwònman)

- Rapò Enpak Anviwònman (EIR) depoze nan Biwo MEPA.
- EIR pibliye nan Environmental Monitor (de fwa/mwa).
- Yo pran kòmantè piblik yo pou 30 jou, epi yo bay desizyon yo nan 7 jou. Desizyon an ka deklare EIR adekwat, oswa, si se pa sa, mande plis EIR.
- ** Apati 1ye janvye 2022, tout pwojè ki toupre kominote EJ yo dwe ranpli tou de etap ki anwo yo, si pwojè a oblije pase nan revizyon MEPA.

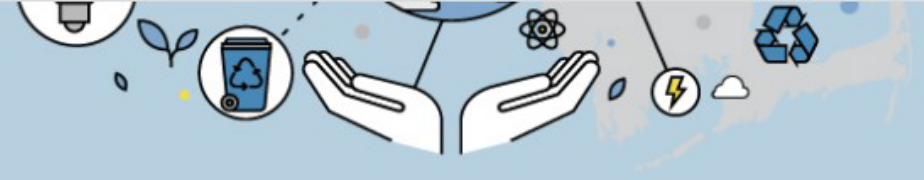
