"We might as well require a man to wear still the coat which fitted him when a boy as a civilized society to remain ever under the regimen of their barbarous ancestors." It is a favorite passage of mine in the occasional discussion on the value of reassessing how the needs of today fit with the words of yesterday. There can be no doubt that the framers of our Constitution were passionate about the work they completed, and then handed off to future generations. Even in the pride they must have felt for that document, they had the wisdom to understand that it would require a mechanism for updating it to account for changes in society that they could not plan for. I am applying to join this Commission because I see that, to paraphrase Jefferson, we are at a point where our institutions are not going hand in hand with progress. The Supreme Court interpreted the Constitution in a way that I cannot fathom the founders would have imagined, or would have appreciated. I believe those appointed to this Commission must have an appreciation for the sanctity of that document, but also an intimate familiarity with how the inequity in access to speech is exacerbated by the Citizens United decision. This body will certainly require legal scholars, but I believe it must also have include perspectives of those who know what it means to be voiceless, undervalued, and aiming to be an advocate.
