# CRA Case File Review: Background

<u>Purpose:</u> to better understand CRA cases, the needs of youth with CRA cases, and the services provided to them.

Collect data on services for youth with a CRA petition including:

- 1. Youth service/interventions <u>needs</u> as identified by a CAFL social worker
- 2. The services/interventions youth <u>received</u> through the CRA process as identified by a CAFL social worker
- 3. The reason why a <u>discrepancy</u> existed between the identified needs and what youth received, if applicable.
- 4. Demographics and general case processing questions

# CRA Case File Review: Background (cont'd)

- Web-based survey created in partnership with CAFL stemming from summer research by an OCA Rappaport fellow
- List of 48 possible interventions across 5 categories:
  - 1. Mental health, physical health and disability related services
  - 2. Family supports and basic needs
  - 3. Mentoring and enrichment programs
  - 4. Education and employment
  - 5. Out of home placements
- CAFL social workers across 10 area offices were asked to randomly select 10 CRA cases that closed in 2020 or 2021 and input the data prompted on the survey
- Data was collected between 1/21/22 through 3/18/2022

#### **Caution Interpreting Results**



The following data **should not be overgeneralized or overstated**. The data presented is based on a nonrepresentative sample of 69 CRA cases that closed between 2020 and 2021.


The following findings should be viewed in combination with the research the CBI Subcommittee has done on the CRA system and the qualitative interviews the OCA conducted.

## CRA Case File Review: Results




## CRA Cases were Reported in 9 CAFL Area Offices

A total of **69** cases were reviewed




## Demographics of Youth: Age and Gender

- Between 7 and 17 years old (Avg. = 14.1, Median= 14)
- Girls were the subject of 32% (n=22) of cases, boys were the subject of 67% (n=46) cases and one case entered was for a youth who identified as genderqueer. One youth identified as transgender during their open CRA Case.




# Demographics of Youth: Race/Ethnicity

#### The CRA Case Process


- 39% (n=27) of cases stayed informal
- In at least\* 28% (n=19) of cases, the case reviewed was not the first CRA petition for the youth
- Over a third (36%, n=25) of the cases lasted longer than a year from the time the CRA was filed to the time it was closed










### 62% of Cases that Needed Mentoring/ Enrichment Supports Did Not Receive Them




# Reasons for Discrepancy: Mentoring/Enrichment Supports




## 42% of Cases that Needed Family/Basic Needs Supports Did Not Receive Them




## Reasons for Discrepancy: Family/Basic Needs




### 26% of Cases that Needed Education/ Employment Supports Did Not Receive Them



# Reasons for Discrepancy: Education/Employment Supports




# 24% of Cases that Needed Mental Health, Physical Health, or Disability-Related Services Did Not Receive Them






# Reasons for Discrepancy: Mental Health, Physical Health and Disability-Related Services




## 19% of Cases that Needed Out of Home Placements Did Not Receive Them

## Many Youth Have Multiple Needs and Receive Many Services

Many youth have complex needs: 55%

(n=38) of cases reviewed involved youth with 4 or 5 areas of need

Many youth received multiple supports/interventions: 39% (n=27) of cases reviewed had 5 or more services/interventions provided

## 20% (n=14) of Youth Received No Services/Supports through the CRA Process

Petition Types: 10 stubborn, 4 truancy

#### **Length of Time:**

- > 90 Days = 4
- 91-180 Days = 8
- 181-270 = 0
- 271 360 = 2
- For one youth, this was not their first CRA. (4 others it was unknown whether this was their first CRA petition or not)

### "Magic wand" Responses: System Level Solutions

- More beds for youth with MH/BH needs (inpatient, residential, emergency)
- Increase in services (MST, Mobile Crises) and whenever possible put them in a centralized location like an FRC
- Increase connections between community organizations, providers and other services to MassHealth/CBHI
- Universal waitlist online for services/ treatment placements and ability to view bed availability/waitlists



### "Magic wand" Responses Pre- CRA Filing

- Must go to FRC before CRA filing
- More FRCs across the state
- More services offered in-house at FRCs (e.g., more direct care MH services, substance abuse disorder treatment)
- Increased service connection at each FRC
- FRCs hire a social worker court liaison in every court
- Annual and ongoing outreach by FRCs to schools, communities, and courts
- MHAP for Kids attorneys at each FRC
- Establish the FRC as community hub and convener
- Re-allocate court funds to community-based organization and FRCs
- Expand DCF Voluntary





### "Magic wand" Responses: Post CRA- Filing

- DMH should expand eligibility for youth with CRAs
- DCF should take over all CRAs
- Dedicated line item to fund more services specifically reserved for youth with CRA filing to increase access to services (e.g., MST, Mobile Crises, peer support, therapeutic mentors, MH/BH supports beyond traditional therapy)
- Incentivize agencies to work together (i.e., shared funding/services)
- Put all CRA services in a centralized location like an FRC
- Increase connections with MassHealth/CBHI through the CRA and Juvenile Court process (e.g., MassHealth court liaisons)
- Trainings (more and better) for: CRA Attorneys, Judges, Attendance Officers, Probation Officers on what the CRA system is and what it can/can't do
