Information from Referrers

- What specifically will referrers be providing to the diversion coordinator?
 - Is this a basic summary of the incident or is it a full police report and/or complaint application?
 - Does it include information about victims and/or witnesses?
- Of this, what will be shared with:
 - o The youth/family?
 - The youth's attorney, if they have one?
 - What can/should be done to protect the confidentiality of victims and witnesses?



Victim Interactions

- What interaction, if any, will Diversion Coordinators have with victims? With victim advocates in DA offices?
- What are the implications of the above for use of restorative justice practices/referral to RJ programs?
- What procedures will be in place to ensure compliance with the Massachusetts Victim's Rights Law?



Interactions with Defense Counsel

- What policies will guide interactions between Diversion Coordinators and defense counsel? What is the role of defense counsel during the development of the diversion agreement?
- Given the interest in diversion being a relatively quick process, how can we ensure involvement of counsel does not lead to a more extended process?
 What time frames will apply to decision-making processes involving defense counsel?
 - For example, if defense counsel is advising a youth on whether to sign the diversion agreement, how many days are allowed for this part of process?
- Will defense attorneys (YAD and bar advocates) be required to participate in any training or orientation to the program?



Communication with Referrer re: Unsuccessful Cases

 Should more information about the case plan and the reasons the plan was unsuccessful be provided to referrers, to increase referrer confidence in the integrity/efficacy of the program?
