Probation presentation on the juvenile pretrial supervision


Types of supervision: Pretrial <u>Probation</u> vs. Pretrial <u>Supervision</u>

- Eligibility
- Procedure
- Violation Proceedings
- Supervision & conditions

Levels of supervision: Category A & Category B

- Goals
- Supervision & conditions
- Non-compliance
- Warrants
- Detention

DYS has 5 Regions



Pretrial Detention Admission

- 1. From arraignment/bail hearing through case resolution
- 2. Intake, screening and assessments
- 3. Detention placement instrument (placement options)

Day-to-day programming & services (education, recreation, visits, court)

- Clinical/Mental Health Services
 - Two clinicians and clinical director on each unit
 - DBT Skills Group
 - Substance Use Group (Prevention or Treatment Track)
 - Access to mental health clinicians/crisis management
- Medical
 - Routine medical care is provided on site by nursing staff
 - All nursing on premises multiple days a week or more and on call services medical needs assessed,
- Psychiatric
 - Medication reviews, continuation, or assessment, if needed

Day-to-day programming & services (education, recreation, visits, court)

- School
 - Education services provide current grade level, High School Diploma track and HiSET
 - Post-Secondary / Vocational Training (in person or online)
 - Youth receive 5.5 hours of education (5 days a week) during the school year, and 3 hours of education during the summer
- Recreation
- Visits

Other considerations:

- 1. Further delinquent behavior/discipline
- 2. Preparing to go home

Challenges with the Process

- Youth can stay in detention from 1 day to 3+ years before resolution of their case
- Motions
- Bail status
- Competency evaluations
- Placement availability
- Waiting for lab files
- YO indictments
- Staffing shortages
