Model Program Guide:

Suggested edits received during review period

Edits based on feedback from the Trial Court to clarify statutory structure for youth referred under judicial diversion M.G.L c. 119 § 54A:

- 1. Note that Coordinators could conduct a risk/need assessment upon request from judge *prior* to referral, to meet statutory requirements
- 2. Add "Provide updates to the court as needed" for youth diverted under this statute to the job description for Diversion Coordinators.
- 3. Add in footnote that explains statutory structure re: diversion timeframes for youth referred under M.G.L. c. 119 §54A (90 days with option to extend another 90).
- 4. Add in that, for judicial diversion cases, once diversion is over the case must come back to the judge for the case to be dismissed.



Model Program Guide:

Suggested edits received during review period

Edits based on conversation with CPCS regarding access to counsel process:

- 1. Upon receiving a referral, Diversion Coordinator contacts CPCS to get the name and contact information for an attorney for the youth.
- 2. When the Diversion Coordinator contacts the youth's parent/guardian to let them know the youth has been referred to diversion, they provide the parent/guardian with the name and contact information for that attorney, and encourage them to contact the attorney before the first intake meeting with the Diversion Coordinator. They will also share the parent's contact information with the attorney to allow for follow-up.
- 3. The Diversion Coordinator will welcome the youth's attorney as a partner in the process, but the youth and their family will not be <u>required</u> to consult with counsel to participate in diversion.
