Child Client Representation

- Model of Representation -- client directed (expressed wishes)
- Mass. Rules of Professional Conduct, Rule 1.14(Client with Diminished Capacity)
- CPCS Performance Standards for Care & Protection Cases, Standard 1.6

(Determining & Advocating the Child Client's Position)

Dually Involved Youth Case Management

"Common" crossover cases:

- CRA pending and youth picks up criminal charges
- Criminal charges are pending and parent/guardian files CRA (sometimes because they do not want their child home)
- Child is in the custody of DCF on a Care & Protection and is being charged with a crime

"Common" crossover case themes

- Placement disruption
- History of significant trauma/CSEC
- Inconsistent services/waitlists
- Educational issues
- Parent/guardian fatigue

CPCS/Court Policies, Practices & Trainings

Are there any other relevant courtroom practices to highlight?

- Judges sometimes hear CRA case first, then delinquency and try not to conflate each case
- Can be difficult when Judge is familiar with client who is struggling on a CRA contract who comes in with charges

Are there any relevant CPCS policies that impact how attorneys work with crossover youth?

- Collaboration between YAD and CAFL offices is encouraged
- Success with CAFL attorneys getting YAD attorneys involved early on in criminal case

Are there any relevant CPCS trainings that inform attorneys on crossover cases?

- Yes, we have training on criminal cases for CAFL clients and training on Care & Protection cases for criminal attorneys
- Edlaw trainings for all attorneys

CPCS Practices

- DIY cases & Social Workers
- Complex cases benefit from SW expertise
- YAD Staff Attorneys have Social Services Advocates
- CAFL Staff Attorneys have Social Workers
- Private Panel Attorneys can request ICCA funds to hire social workers
- CPCS trainings focus on benefits to clients & counsel of using social services experts

- COLLABORATION! All parties talking and trying to be creative to create better youth outcomes
- Utilizing SSAs or Court Clinic Case Management
- Utilizing EdLaw's expertise

Any innovative models or emerging practices to highlight?

- Wrap around services that provide 24/7 care to families on CRAs to keep children at home
- Not utilizing criminal charges to enforce issues more appropriate for CRA
- Diversion
- Utilization of Family Resource Centers
