Chairman Hanson called the meeting to order at 11:03 A.M.

#### • Administrative updates:

Vote to accept the full Committee meeting minutes from February 23, 2023.

Motion by Andrews, seconded by Mazzarella: to accept the minutes from the full Committee meeting on February 23, 2023, as presented.

#### The Motion passed unanimously.

#### • Chairman's Report:

Mr. M. Reddy left the meeting and was not present for the duration of the Chairman's report.

Chairman Hanson reported that there was some confusion around the Lynn Fire case. He further reported that he was re-convening the 3(a) panel and would give the parties an opportunity to present something in writing and that this would be scheduled as soon as possible.

Mr. M. Reddy returned to the meeting after the conclusion of Chairman Hanson's report.

Mr. Hubley briefed the Committee and reported that the parties had settled prior to arbitration but will need to craft a stipulated award to include retroactive pay.

Motion by M. Reddy, seconded by Mazzarella: to authorize a stipulated award in the case of Wayland Firefighters, Local 1978 and the Town of Wayland, JLM-21-8988.

The Motion passed unanimously.

Mr. Morgado briefed the Committee and reported that the contract had been funded by the city.

Mr. Mazzarella spoke on the recent trend of settlements validating the hard work of the parties, staff and especially committee members. He commented that a voluntary settlement is far better than one imposed.
