Chairman Hanson called the meeting to order at 11:01 A.M. The Meeting was recorded.

Chairman's Report:

Chairman Hanson reported that he had received a letter from Mike Perreira regarding a dispute over the Springfield Superiors arbitration decision. He further reported that the arbitrator will not address an issue with the decision unless both parties agree to a review. In substance, Chairman Hanson expressed his willingness to call the parties together for a mediation. Chairman Hanson also raised the possibility of asking for an opinion from legal counsel.
