# **OPEN SESSION**

Chairman Hanson called the meeting to order at 11:04 A.M.

The meeting was recorded by Chairman Hanson.

# Administrative updates:

Vote to accept the full Committee meeting minutes from July 15, 2021.

Motion by Cross, seconded by Goldsmith: to accept the minutes from the Committee meeting on July 15, 2021.

The Motion passed unanimously.

 Act to appoint Rosemary Pye, Esq. and Leslie Williamson, Jr., Esq. to the arbitrator list maintained by the Committee.

Chairman Hanson introduced Rosemary Pye and Leslie William who have applied to be included on the list of JLMC arbitrators. There were no questions from the Committee. The Chairman called for a motion.

Motion by Goldsmith, seconded by Cross: to appoint Rosemary Pye and Leslie Williamson to the Committee's list of arbitrators.

The Motion passed unanimously.

### Chairman's report:

• Discussion on the practice of case assignments of Committee Members

Chairman Hanson opened a discussion on the appointment of Committee members to cases where multiple bargaining units from the same municipality have cases before the Committee at the same time. Mr. T. Reddy mentioned the possibility of conflict where two cases are being arbitrated at the same time. Mr. Hanson noted that each side has always appointed their own committee members; that the Committee can always talk about it if there's an issue; and that it's up to the chairs to appoint their committee members without interference. Ms. Goldsmith would prefer status quo and noted that the Committee can talk about it if there is an issue and that any issues can be brought up at a Committee meeting or with staff. Mr. Perreira stated that assigning the same committee member to multiple cases in the same municipality at the same time should be avoided unless there is a good reason. Mr. Andrews mentioned that two sets of eyes would have been good in a case where he had been assigned as a committee member for two units. Ms. Aicardi felt that there was no need for a rule and that the situation should be handled with professional courtesy. Mr. Hanson recommended sticking with the status quo and that any potential conflict with a case should be discussed at a Committee meeting. Mr. M.Reddy said that he would not be making a motion on the matter. Mr. Hanson said that the current practice would

remain status quo and if an issue arises it can be brought up and discussed. The Committee took no action.

Mr. Hubley and Mr. Driscoll briefed the Committee. Mr. Driscoll noted that there is a dispute as to the number of on-the-record bargaining sessions and the Town asserts the right to make additional on-the-record proposals in accordance with the parties' ground rules prior to mediation, which will be noted in the investigation report. The parties are encouraged to work out this issue among themselves prior to mediation.

Motion by Cross, seconded by Goldsmith: to take jurisdiction in the case of the Cohasset Permanent Firefighters, Local 2804 IAFF and the Town of Cohasset, JLM-21-8682.

Motion by Andrews, seconded by Goldsmith: to find that in the matter of Holliston Police Association and the Town of Holliston, JLM-21-8598, the issues have remained unresolved for an unreasonable period of time resulting in the apparent exhaustion of the process of collective bargaining, and that the Committee vote to hold a hearing pursuant to Section 1, subsection 3(a), as set forth in Chapter 589 of the Acts of 1987, with the panel members consisting of Thomas Reddy (Labor) and Tony Mazzucco (Management), or other Committee members and/or senior staff that may be substituted as necessary by the respective Labor and/or Management Chairs pursuant to the rules, policies, and procedures of the Committee, and any other applicable provisions of law, with said panel being chaired by John Hanson.
