1. JLM-23-10043 Winchester Patrol GD/DC Awaiting Funding

George Driscoll briefed the Committee and reported that after staff and committee level mediations, the parties were able to reach agreement during a mediation at the 3(a) hearing. The union has ratified and the Town is voting to fund the contract at town meeting on November 7.
