Chairman Hanson called the meeting to order at 11:11 A.M.

The Chair made some general opening comments and greetings and advised that the meeting was being recorded. The Chair called the roll of those present.

### • Administrative updates:

Motion by Mazzarella, seconded by Cross: to accept the minutes from the Committee meeting on October 27, 2022, as presented.

The Motion passed unanimously.

Chairman Hanson advised the Committee Chairs to check the term dates of their gubernatorial appointments.

Mr. Driscoll briefed the Committee and reported that the petition had been jointly filed, the investigation had been completed and that he and Mr. Cummings were recommending jurisdiction.

Mr. Morgado briefed the Committee.

Motion by Mazzarella, seconded by Andrews: to find that in the matter of Arlington Police Patrolmen's Association and the Town of Arlington, JLM-22-9174, that there is an apparent exhaustion of the processes of collective bargaining which constitutes a potential threat to public welfare and that the Committee vote to send this case to arbitration by a tripartite panel consisting of Alan Andrews (Labor) and Richard Tranfaglia (Management) ) and/or other Committee members and/or senior staff that may be substituted as necessary by the respective Labor and/or Management Chairs pursuant to the rules, policies, and procedures of the Committee, and any other applicable provisions of law, and a neutral selected in accordance with the Committee's rules, policies and procedures, on an issue by issue basis, with said issues having been identified at the November 9, 2022, hearing held pursuant to Section 1, Subsection 3(a), of Chapter 589 of the Acts of 1987.

## **o** Other Business

Mr. Perreira opened a discussion that went substantially as follows. Mr. Perreira requested that 3(a) hearings, arbitrations and JLMC meetings be conducted in-person. Mr. Cross advocated for in-person meetings. Mr. Bain objected to in-person committee meetings but felt 3(a) hearings might be conducted in-person. Mr. Andrews agreed with Mr. Bain and suggested hybrid Committee meetings but 3(a) hearings in-person. Mr. Hanson cited the difficulty of people driving long distances but suggested that 3(a) hearings be conducted in person unless the parties agree otherwise; that committee level mediations be conducted in-person at the discretion of the parties in consultation with staff. Mr. Cummings and Mr. Hanson noted the difficulty in scheduling. Mr. Morgado discussed the convenience of scheduling investigations remotely and the difficulty of coordinating too many participants. Mr. Driscoll noted that he had scheduled two remote 3(a) hearings this month; one police and one fire.
