Review and Act on the following Petition, Jurisdiction and Awaiting Funding List (AFL) Cases

1. JLM-24-10679 Somerville Police Superiors GD Funded/Remove

George Driscoll briefed the Committee and reported that this case had several mediations and was voted to arbitration but the parties were able to reach agreement before arbitration and the contract has been funded.

Motion by Mazzarella, seconded Andrews: to remove the case from the Committee's docket as the contract has been funded by the City.

The Motion passed unanimously.

2. JLM-25-11140 Holden Police GD Funded/Remove

George Driscoll briefed the Committee and reported that, after two staff mediations, the parties met on there own to resolve the remaining areas of disagreement. The contract has been fully ratified and funded by the Town.

Motion by Mazzarella, seconded Andrews: to remove the case from the Committee's docket as the contract has been funded by the Town.

The Motion passed unanimously.

3. JLM-25-11144 Whitman Fire GD/JH Move to Awaiting Funding List

Joe Hubley and George Driscoll reported that two staff mediations were sufficient to get the parties close and that, after additional negotiation, the parties were able to reach agreement. The contract has been ratified and is awaiting funding.

Motion by M. Reddy, seconded by Mazzarella: to move the case the Awaiting Funding List.

The Motion passed unanimously.

4. JLM-25-11325 Bourne Fire GD/JH Move to Awaiting Funding List

George Driscoll briefed the Committee and reported that, at the investigation conferences, the parties were encouraged to keep meeting on their own and, in fact, were able to reach agreement. The contract has been fully ratified and is awaiting funding at the fall town meeting.

Motion by M. Reddy, seconded by Mazzarella: to move the case the Awaiting Funding List.

The Motion passed unanimously.
