FINAL DECISION

In accordance with the Adjudicatory Proceeding Rules at 310 CMR 1.01(14)(b), Bonnie Heiple, Commissioner of the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”), has designated me the Final Decision-Maker in this administrative appeal.¹

I have reviewed and hereby approve the attached Settlement Agreement by Administrative Consent Order with Penalty and Notice of Noncompliance executed on August 24, 2023 by Ronald Smalling, Owner of JNR Freight Corp., and on September 7, 2023 by Mary Jude Pigsley, Regional Director for the Massachusetts Department of Environmental Protection (“the Department” or “MassDEP”) (ACOP 00016258), to settle this appeal.

Under the terms of 310 CMR 1.01(8)(c), this proceeding is dismissed with the parties waiving whatever rights they may have to further administrative review before the Department as well as any appeal to court.
