Before founding his consulting practice in 1983, John Bos served as Director of Performance Programs for National Public Radio where he earned a Peabody Award for "meritorious service in broadcasting". Following his NPR tenure, John served as the host for *Arts America*, a weekly cultural television program produced by the United States Information Agency and distributed worldwide.

As Deputy Director for the New York State Council on the Arts in the late 70's, John was in charge of a \$15 million budget for grants to dance, music, theater, and presenting organizations. At NYSCA he created the Presenting Organizations Program to provided funding support directly to nonprofit presenters throughout the state.

Prior to his NYSCA appointment by Kitty Carlisle Hart, John served as Director of Field Services for the Foundation for the Extension and Development of the American Professional Theater. He was responsible for FEDAPT's national technical assistance program.

On the home front, at the request of violinist/composer Arnold Black, Bos served as the Executive Director of the Mohawk Trail Concerts 25th anniversary season. He created the non-profit RURAL Renaissance in Ashfield, Massachusetts in 1996. RURAL Renaissance was created to integrate the performing arts into the fabric of a small town community by presenting first class performers in the historic Ashfield Town Hall. Bos presented 14 music and theater events from September 1997 through June 1998.

His newspaper column "Connecting the Dots" appears bi-weekly in the Shelburne Falls West County Independent. His op ed essays have appeared in a number of regional newspapers including the Iowa Press Citizen, the Springfield (MA) Republican, the Worcester Telegram and the Brattleboro (VT) Reformer. He is a monthly op ed contributor to the Greenfield (MA) Recorder.
