FINAL DECISION

I am the Final Decision-Maker in this administrative appeal (“appeal”) by special designation.

The Petitioner Duxbury Conservation Commission has filed a voluntary withdrawal of this appeal. The Petitioner’s voluntary withdrawal constitutes a waiver by the Petitioner to any further administrative review before the Department of Environmental Protection (“the Department” or “MassDEP”) as well as appeal to court of the Superseding Order of Conditions (“SOC”) that was issued by the Department on May 24, 2016 and was the subject of this appeal. The Petitioner’s waiver is further confirmed by recent correspondence of January 11, 2024 that the Department’s Office of Appeals and Dispute Resolution (“OADR”) received from the

Applicant's counsel. Accordingly, the Department issues this Final Decision affirming the SOC, incorporating the Petitioner's voluntary withdrawal of the appeal, and dismissing this appeal.
