

### **FINAL DECISION**

I have reviewed the attached Administrative Consent Order with Penalty and Notice of Noncompliance signed on February 15, 2017 by Rosanie Joseph and Adrien Joseph, and on March 2, 2017 by Millie Garcia-Serrano, Regional Director for the Department (PAN-SE-16-3R-Z001-SETT).

The Department issues this Final Decision incorporating the Administrative Consent Order with Penalty. The petitioners are ordered to pay a civil administrative penalty of five thousand dollars (\$5,000) with the entire penalty amount of five thousand dollars (\$5,000) suspended contingent upon the petitioners' compliance with the terms of the settlement agreement in accordance with paragraphs 11, 16 and 26 of the Administrative Consent Order with Penalty. Under the terms of 310 CMR 1.01(8)(c), this proceeding is dismissed with the parties waiving whatever rights they may have to further administrative review before the Department as well as any appeal to court.
