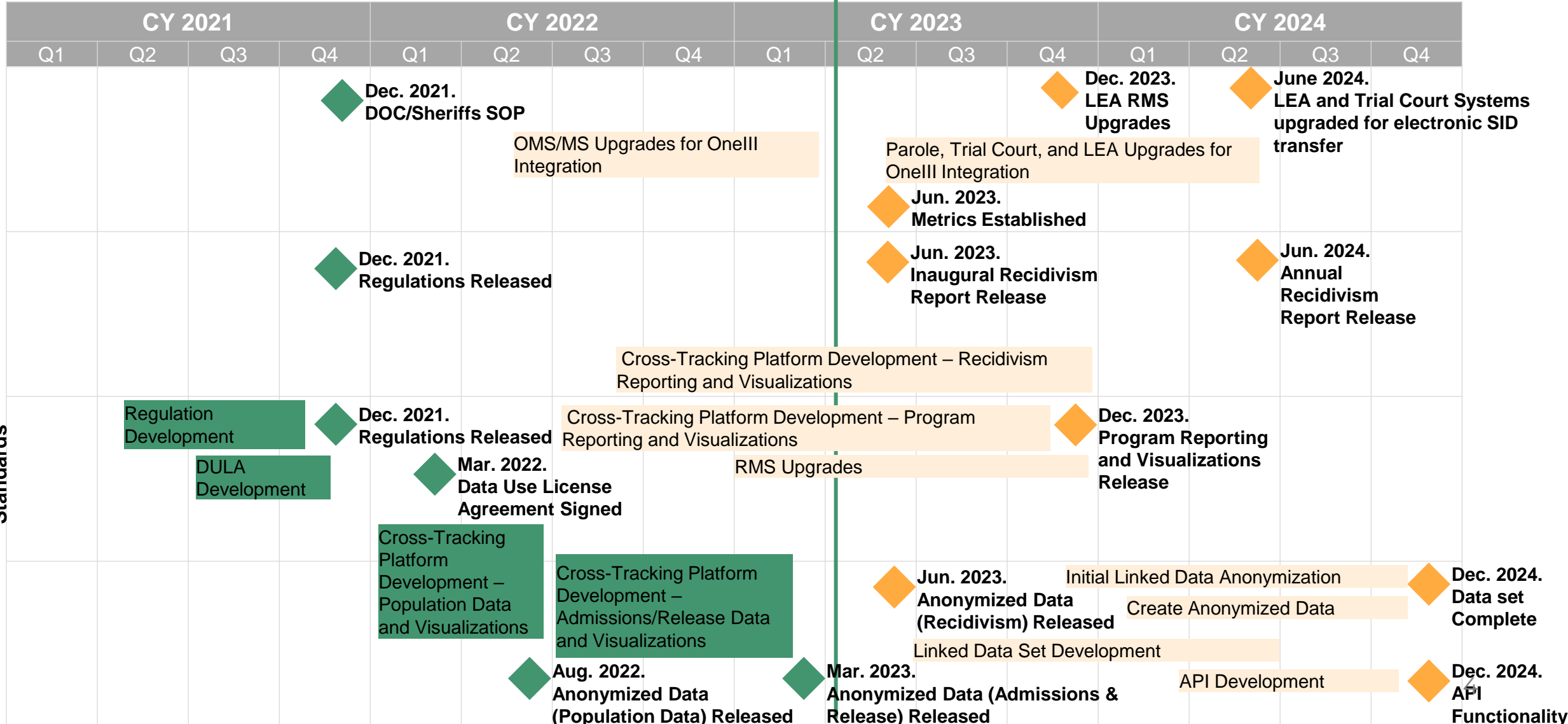

<b>Unique ID:</b> The cross-tracking system shall require all criminal justice agencies and the judiciary to use a unique state identification number assigned to each person who enters the criminal justice system. All criminal justice agencies and the trial court shall incorporate the unique state identification number into their data systems upon a person’s initial transfer to their jurisdiction. <b>Recidivism Reporting:</b> Re-arraignment, reconviction, and reincarceration rates published over 1, 2, and 3-year periods by race, ethnicity, gender and age. The data shall be submitted by each criminal justice agency and the judiciary to the secretary who shall subsequently publish the information quarterly on the executive office of public safety and security website. 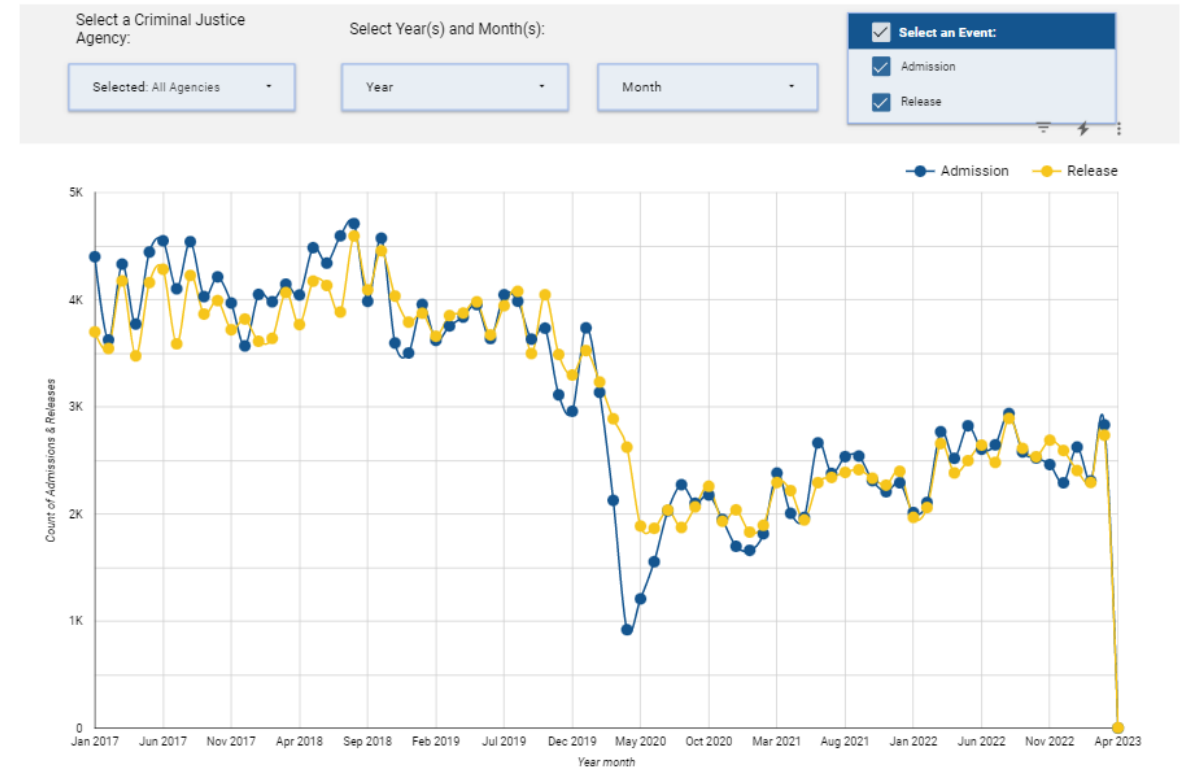
- Public dashboard updated to include Admissions and Release data

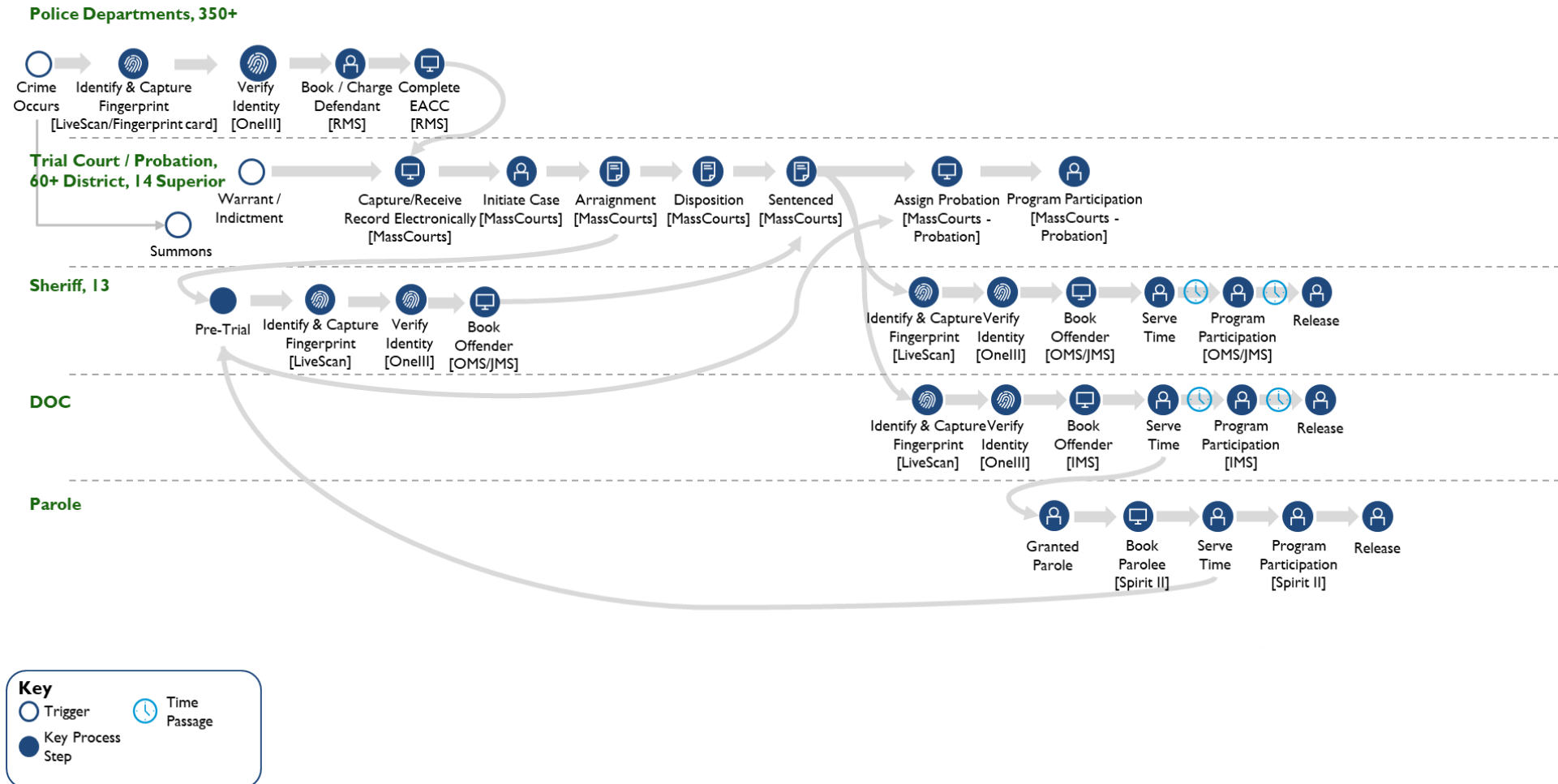
