

Statement of Intent	I intend to comply with and advance the policy established by this Act.
Statement of Interest	I have been voting since 1974, when I was 19. That first election was a rite of passage for me-after years of arguing politics with my father, my opinion would finally matter! I've been a proud and active voter since then, taking to heart what I was taught by my parents and teachers: There are two ways for regular citizens to have a voice in government-vote in elections and serve on a jury.
	While I still believe that voting is essential, I also believe that the power of my vote has been diminished. And it's been diminished by money. When the Supreme Court decided that corporations have the same rights as individuals to make political expenditures, the voice of the individual was muted. With millions of dollars, corporations and super PACs are dominating the political discourse in the United States and exerting too much influence on election outcomes.
	Overturning Citizens United v. FEC is essential to restoring control of our elections, and therefore our government, to the people. This is not a partisan issue; a study by the University of Maryland and nonpartisan research group Voice of the People indicates that "66 percent of Republicans and 85 percent of Democrats back a constitutional amendment outlawing Citizens United."
	With the same pride and trust in our democratic process I had in 1974, I humbly submit this statement of interest. It would be a great honor to serve on the Citizens Commission to help advance a 28th Amendment to get big money out of politics.
