The execution and delivery thereof to be conclusive evidence that the same has been authorized by the Board of Directors of the Corporation on behalf of the Partnership and PPPLP.

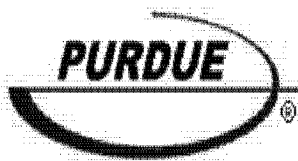

### Field Contact Report Investigation

In March 2009, Purdue discovered that certain of its District Managers may have failed to complete certain Promotion Monitoring Program (PMP) activities required by the CIA. Purdue promptly notified OIG of its discovery of this potential issue; promptly conducted a nationwide investigation to determine if this issue was isolated or widespread and assessed possible causes of the problem; took remedial action, including obtaining OIG approval to utilize an interim approach to ensure timely completion of PMP requirements in delinquent districts; re-trained personnel; implemented many new procedures to prevent a recurrence; and re-evaluated and submitted to OIG revised relevant data initially reported in the Annual Report for the first reporting period.

On September 17, 2009, Purdue informed OIG that all the commitments made by Purdue's had been accomplished and provided a supplement to your first Reporting Period Certification. On November 24, 2009, OIG informed "At this time, we have no further questions about this matter."

### OxyContin Savings Card Investigation

In March 2009, Purdue discovered and investigated representative call notes containing references to savings cards and federal healthcare programs. Use of the savings cards with such programs is unlawful, and explicitly prohibited by the terms of the cards themselves. Letters and calls with OIG have fully explained our investigation, including a letter from counsel dated August 4th responding to OIG questions about details of the card program. On November 24<sup>th</sup>, OIG concluded "Purdue has met its reporting obligation under the CIA with respect to the OxyContin Savings Card issue."

Purdue has implemented new procedures with its savings card administrator, Triple I, to further minimize prospects of improper use of such cards by beneficiaries of such Federal government health plans.

### Aggregate Spend Project

In preparation for new pharmaceutical reporting requirements contained in the Federal Physician Payments Sunshine Act, Purdue has worked with Huron Consulting to map current Company HCP

spend data capabilities against anticipated reporting requirements. An automated system for preparation of anticipated Federal and state reports will next be under development in-house with IT.

**1. Compliance**

- 1.1 Does the fact that some representatives appear to have promoted Ryzolt for the treatment of mild pain signify a “failure” in sales training? Also, given our past experience with promotion of OxyContin, is the training of our representatives broad, deep and significant enough on new products?

While there may have been some level of confusion with the analgesic “step training” (i.e. WHO ladder of treatments for mild, moderate and severe pain) considering the absolute number of sales calls and the very low incidence of reference to “mild” or “milder” pain, legal/compliance believe the sales training was both adequate and appropriate. In a broader sense, we are faced with ongoing and significant changes in pharma regulations, both at the state and federal level, and ensuring adherence to and compliance with these changing demands is under close and constant scrutiny.

- 1.2 Is the cost of tracking our expenditures on meals and other expenditures on healthcare providers exceeding the costs themselves?

No, the tracking costs are actually quite modest. Moreover, even if we decided to eliminate all such expenditures, we would still need the tracking systems – to meet the data reporting and quality system requirements of some of the legislation.

- 1.3 There is a lack of clarity about reporting requirements for personal contributions/expenditures by Directors. Specific and clear guidance is required for both political contributions and interactions, as well as for meal and entertainment expenses by Directors – for both Purdue and ex-Purdue purposes.

As the Board members will recall, a recent memo on Lobbying Disclosure requirements was disseminated to the Board. If there are follow-up questions

## 2.7 Why is there no reference to efficacy data in the marketing materials?

Sales and Marketing are currently working closely with Clinical, Legal and Regulatory to determine what specific efficacy statements can be made – given the products approved labeling and supporting clinical trial data. The discussion of efficacy is included in the selling materials; however a specific reference or statement to Butrans providing efficacy for 7 days seems to be the desired statement. Due to the design and data collection schedules in the Phase III clinical study program, we may not have data that supports efficacy at that specific time point. There are sections of the promotional materials that discuss the results of the two pivotal trials that demonstrated efficacy versus placebo, which were the basis for FDA approval.

## CORPORATE COMPLIANCE

Assure compliance with Purdue's Corporate Integrity Agreement (CIA) and all Federal and State laws and regulations, as well as the PhRMA Code. Conduct risk assessments and audit and monitor business operations. Respond as required to all inquiries and conduct investigations of Company operations when appropriate. Assure that all ethics and compliance training requirements are met.

### Corporate Integrity Agreement

- Year three of Purdue's five year CIA closes as of July 30, with all requirements met for this period. Recall that in years one and two, there were issues with respect to meeting the required quantity of Field Contact Reports (FCRs); this year we and Sales have monitored this activity closely and have over twice as many of the required day's worth of FCRs.

### Public Citizen Freedom of Information Act (FOIA) Request to OIG for Disclosure of Purdue CIA Annual Reports

- OIG is in near full agreement with Purdue's approach to redacting information from CIA Annual Reports prior to disclosure to Public Citizen. In April we exchanged correspondence with OIG concerning their version of our redacted documents. Our only point of difference was our request that the names of specific individuals should be redacted. We have heard nothing further since April.

### State Law Reporting

- All required state law compliance reports were timely filed on or prior to July 1st for Massachusetts, Maine, and the District of Columbia. Connecticut has just implemented a law that requires pharmaceutical companies to abide by the PhRMA Code as well as OIG's 2003 Compliance Guidance for Pharmaceutical Manufacturers, a heretofore voluntary guidance document; Purdue will be in full compliance

# **Epidemiology and Lifecycle Plans for OxyContin<sup>®</sup>**

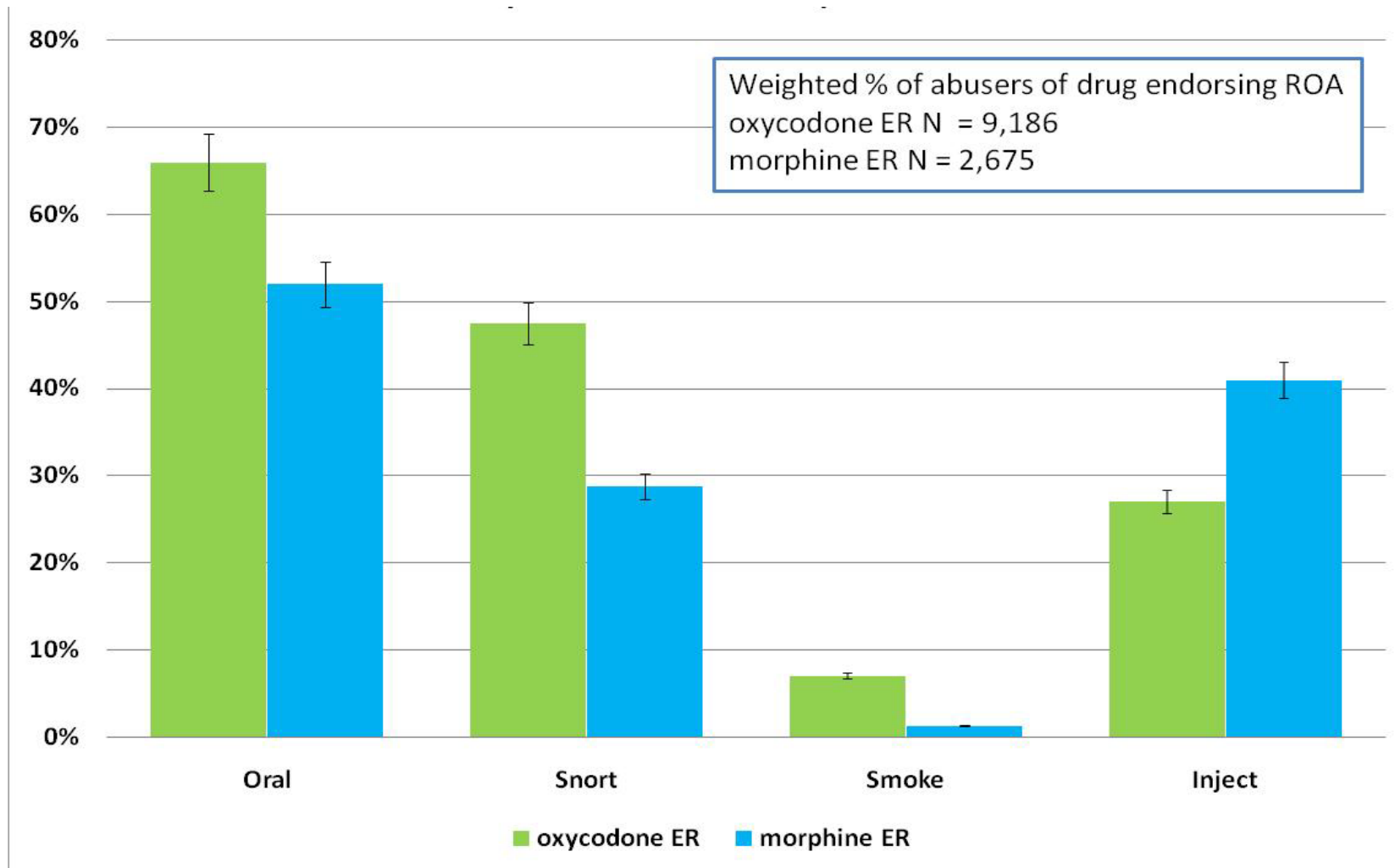

It was indeed an informative and enjoyable meeting with Jim, Chris and Jianren (with a cameo by Jeanine Wiener-Kronish for good measure), and given that I stated we are going to resume funding - please work with Ed to see that \$500K is paid this calendar year.

Both Jim and Jianren seem genuinely interested in working collaboratively with our basic and clinical drug development groups (I have already mentioned the meeting and their willingness to get-together to Gary) as well as on broader issues such as the forthcoming class REMS for opioids, prescription monitoring programs, etc.

As we discussed, with only \$1.5 million remaining to complete the funds "promised" by the original agreement, I don't think that it will be worthwhile to rewrite/revise that document at this point. However, I am certain that they will be interested in continuing the relationship beyond the initial term, so it would be useful for the CEAC Group as well as R&D to think about what we would ideally want the investment in this program to make happen/deliver. Over the remainder of this initial term, we can assess how the program has performed - which will certainly make the subsequent decision on renewal a lot more straightforward.
