FORMER DIRECTORS' REPLY IN SUPPORT OF THEIR SUPPLEMENTAL MOTION TO DISMISS

In the their memorandum of law served on May 10, 2019, the Commonwealth addressed their opposition to Defendant Russell Gasdia's Motion to Dismiss; Defendants Craig Landau, John Stewart, and Mark Timney's Joinder in Defendant Russell Gasdia's Motion to Dismiss; the Supplemental Memorandum in Support of Former Directors' Motion To Dismiss; and John Stewart's Motion to Dismiss on Statute of Limitations Grounds. In so far as Defendants Beverly Sackler, Paulo Costa, Ralph Snyderman, and Judith Lewent (collectively "Former Directors") ceased to serve as a member of the PPI Board before the Commonwealth filed this action on June 12, 2018 (*see* FAC ¶¶ 49, 499), they join defendant Russell Gasdia's Reply in Support of his Motion to Dismiss. The Attorney General does not have the authority to sue former directors no longer engaged in or likely to engage in the alleged conduct under G.L.c. 93A § 4. The Attorney

General also does not have the authority to bring claims against the Former Directors to abate or enjoin the current public nuisance alleged in her complaint.
