Honorable Chairs and Ranking Minority Members of the Committees on Ways and Means:

Pursuant to Section 6 of Chapter 14 of the General Laws¹, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of July 2016. The attached table shows July 2016 month-to-date and Fiscal Year 2017 year-to-date tax revenue collections through July 15, 2016, along with changes from the same collection period in July 2015.

Highlights:

Please note that at the time of the mid-month estimate, the available tax collection data is too early to provide a reliable estimate of full-month results. It would not be advisable to use this data to predict trends.

• Month-to-date **Total Tax Collections** were \$661 million, up \$103 million from the same period last July.

- Month-to-date **Income Taxes** totaled \$486 million, up \$38 million from the same period last July.
- Month-to-date **Sales & Use Taxes** collections were \$101 million, up \$37 million from the same period last July.
- Month-to-date **Corporate & Business Taxes** total \$40 million, up \$19 million from the same period last July.

Details:

July is among the smaller tax collection months, as there are no quarterly estimated payments due for most businesses and individuals, with the exception of corporations in the retail industry whose quarterly estimated payments are generally due in January, April, July and October.

The Total Tax Collections of \$661 million at mid-month July 2016 is \$103 million higher than the same period last year. At a more detailed level:

Income Taxes totaled \$486 million, which is \$38 million more than in the same period last year. Within this category:

- Income Withholding at \$460 million and \$36 million more than mid-month July 2015, constitutes the overwhelming proportion of the dollars collected and of the increase over prior year.
- Estimated Payments is the one category in which the mid-month July 2016 is lower than prior year. Collections were \$11 million in the month-to-date period, which is \$2 million less than the same period last year.
- Income Returns/Bills at \$16 million is \$4 million more than the equivalent mid-month period in 2015.
- Income Refunds are extremely small in the period.

Sales & Use Tax collections of \$101 million comprise \$53 million in Regular Sales, \$14 million in Meals, and \$34 million in Motor Vehicles. As the detailed exhibit shows, each of these categories is positive versus mid-month July 2015. While positive for this brief period, it is too early to project a trend from these figures.

Month-to-date Corporate & Business Tax collections totaled \$40 million, up \$19 million from the same mid-month period in July 2015. This represents an increase over the prior year, but the actual dollar amounts are relatively small and may not represent a trend.

All Other Taxes, which includes motor fuel and cigarette taxes among its larger components, were \$34 million for the July month-to-date period and \$8 million above the same period in 2015.
