### FY 2021 COLA Update

At the time of this writing, the Legislature had not yet acted on a COLA (Cost-of-Living Adjustment) for eligible retired state employees for the 2021 fiscal year. Typically, the COLA is a line-item within the Commonwealth's fiscal year budget if enacted by the Legislature. If a COLA is approved, benefit recipients will receive the COLA as soon as administratively possible with their regular monthly benefit payment.

#### 2020 BVF Update

The first retiree Benefit Verification Forms (BVF) were mailed early July and are due back to the Board by August 7, 2020.

It is acceptable to return the form after the deadline of August 7, 2020, without harming a member's benefit payment. A second BVF will be mailed sometime in September to all benefit recipients who were not able to return the first BVF.

Note, the Board processes over 60,000 BVFs and will confirm receipt of an individual BVF starting in August. In the meantime, members whose BVF has been received and validated may receive a postcard that acknowledges receipt.

## Did You Know?

The MSRB has partially re-opened its offices to telephone traffic between the hours of 9:00 a.m. and 3:00 p.m. (Monday – Friday), and have limited staff working onsite and others remotely. There continues to be no public access to our Boston and Springfield offices.

MSRB staff added more than 900 new retirees / beneficiaries to the pension payroll for the period since March through the end of June.

Additionally, staff has received and responded to more than 35,000 telephone calls and over 9,000 emails during the same period.

#### Treasurer Goldberg Warns of Unclaimed Property Scam Text Messages

Fraudulent text messages are being sent claiming to be from the Massachusetts Unclaimed Property Division (UCP). The texts say that there are available funds under your name and to visit the link provided. According to Treasurer Deborah Goldberg, these texts are a scam and have not been sent by UCP.

"It has come to our attention that text messages claiming to be from the There is no notarization requirement, but the BVF must be witnessed by someone aged 18 or older.

Your spouse or someone else living in your home may witness your BVF.

Benefit recipients will continue to receive their monthly benefit as usual during the BVF process.

If the benefit recipient has passed away, there is no need to return the form. Instead, please notify the Board of their passing and mail a copy of their Death Certificate to the Board at One Winter St, 8th FL Boston, MA 02108.

#### Please note: You will not be required to submit a form if you retired or started receiving a pension benefit this year (2020).

It has also come to our attention that illegitimate unemployment benefit claims are being made falsely representing people's identities. It is important to be aware of such scams in order to protect yourself.
