# **Traffic Detours: July 21 through August 4**

#### What is happening?

From July 21 to August 4, MassDOT will begin early activities to establish a safe work zone in preparation for future construction operations. To enable these operations, temporary roadway impacts and detours will be in place as needed on the routes listed below:

- Exit 25 I-195 Eastbound to Penniman Street
- Cedar Grove Steet Ramp onto I-195 Westbound
- Route 18 Northbound Ramp to I-195 (Ramp E)
- Purchase Street Southbound (drivers and pedestrians)
- Exit 28 I-195 Westbound to Coggeshall Street (Ramp J)


#### **How Will This Affect You?**

The following impacts and detours are anticipated during the hours shown below.

#### Closure of Exit 25 I-195 Eastbound to Penniman Street

This exit will be closed as needed during **overnight hours** (7:30 p.m. - 5:30 a.m.). During the closure, drivers should:


- Continue on I-195 eastbound and take Exit 27.
- After exiting, turn right onto Belleville Avenue
- Turn left onto Coggeshall Street
- Turn left onto Mount Pleasant Street
- Turn left onto Penniman Street



## Closure Cedar Grove Steet Ramp onto I-195 Westbound

This on-ramp will be closed as needed during **overnight hours** (7:30 p.m. – 5:30 a.m.). During the closure, drivers should:


- Proceed to Mount Pleasant Street
- Turn right onto Coggeshall Street
- Proceed on Coggeshall Street to access I-195 westbound via the on-ramp



## Closure of Route 18 Northbound Ramp to I-195 (Ramp E)

This on-ramp will be closed as needed during **overnight hours** (7:30 p.m. -5:30 a.m.). During this closure, drivers should:

- Continue north on Route 18
- Turn right onto Coggeshall Street
- Turn right onto Belleville Avenue
- Turn left onto Washburn Street and follow the detour signs to access I-195 eastbound



#### **Closure of Purchase Street Southbound (drivers)**

A section of Purchase Street southbound will be closed as needed during **daytime hours** (7:00 a.m. – 5:00 p.m.). During this closure, southbound drivers should:

- Turn left onto Coggeshall Street
- Turn right onto Route 18 southbound
- Take the exit onto Weld Street




## **Closure of Purchase Street (pedestrians)**

A section of Purchase Street southbound will be closed as needed during **daytime hours** (7:00 a.m. – 5:00 p.m.). During this closure, northbound pedestrians should:

- Turn left onto Penniman Street
- Turn right onto County Street
- Turn onto Cedar Grove Street

During this closure, southbound pedestrians should:


- Turn right onto Cedar Grove Street
- Turn left onto County Street
- Turn left onto Penniman Street



# Closure of Exit 28 I-195 Westbound to Coggeshall Street (Ramp J)

This exit will be closed as needed during **overnight hours** (7:30 p.m. – 5:30 a.m.). During this closure, drivers should:

- Continue on I-195 westbound
- Take Exit 24A
- Take Exit 2A toward Cape Cod to merge onto I-195 eastbound
- From I-195 eastbound, take Exit 27 on the right



### Travel tips

Drivers should take care to pay attention to all signage and move carefully through the work zone. Police details, lane markings, temporary barriers, traffic cones, signage, and other tools will be used to control traffic and create safe work zones.
