Route I-195 to Route 18 Interchange Rehabilitation Project, New Bedford

Short-Term Rolling Roadblocks: July 28

What is happening?

From 2:00 a.m. to 5:00 a.m. on Monday July 28, rolling roadblocks will be utilized on a short-term, temporary basis to stop traffic for brief, 20-minute periods on I-195 eastbound and associated on-ramps in New Bedford. Rolling roadblocks are being used to allow crews to safely and effectively conduct necessary construction operations. Police detail will be present.

How Will This Affect You?

These traffic impacts will take place on I-195 eastbound between Faunce Corner and the Acushnet River in New Bedford, as well as on the Faunce Corner, I-140, and Route 18 on-ramps. Individuals traveling through the area during this time will experience short-term traffic delays. Drivers are advised to plan ahead, recognize upcoming impacts, and seek alternate routes as appropriate.

Travel tips

Drivers should take care to pay attention to all signage and move carefully through the work zone. Police details, lane markings, temporary barriers, traffic cones, signage, and other tools will be used to control traffic and create safe work zones.
