Honorable Chairmen and Ranking Minority Members of the Ways and Means Committees:

Pursuant to Section 6 of Chapter 14 of the General Laws¹, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of June 2016. The attached table shows June 2016 month-to-date and Fiscal Year 2016 year-to-date tax revenue collections through June 15, 2016, along with the dollar and percentage changes from the same collection period in June 2015. Also shown are the percentage growth amounts for the full month of June 2016 and for Fiscal Year 2016 year-to-date through the end of June 2016 that were assumed in the benchmarks corresponding to the revised Fiscal Year 2016 tax revenue estimate of \$25.751 billion². The \$25.751 billion estimate does not include the

current of \$95 million for tax and non-tax related settlement and judgment payments in excess of \$10 million each.

Highlights:

- It is too soon for the month-to-date collections to be meaningful to gauge full month's revenue performance; the majority of monthly collections typically come in during the second half of the month.
- Month-to-date *total tax collections* are up \$38 million from the same period last June.
- Month-to-date withholding totals \$491 million, up \$19 million from the same period last June.
- Month-to-date income tax cash estimated payments total \$144 million, down \$8 million from the same period last June.
- Month-to-date *income tax cash refunds* total \$38 million, down \$0.5 million from the same period last June.
- Month-to-date *income tax payments with returns and extensions* total \$30 million, up \$1 million from the same period last June.
- Month-to-date sales and use tax totals \$96 million, up \$15 million from the same period last June.
- Month-to-date corporate and business taxes total \$474 million, up \$21 million from the same period last June.

Details:

June has historically been the second largest tax collection month of the year after April as quarterly estimated payments are due for both income tax and corporate and business taxpayers. The June monthly benchmark corresponding to the Fiscal Year 2016 tax revenue estimate of \$25.751 billion totals \$2.806 billion, an increase of \$150 million, or 5.6% actual and 4.1% baseline from June 2015. The net incremental impacts of tax law changes on tax collections are negligible this month, reflecting mostly the revenue gain due to the 2016 amnesty program offset by revenue loss due to the recent reduction in part B personal income tax rate, as well as net revenue impact from other tax law changes.

Through June 15, 2016, month-to-date tax collections totaled \$1.268 billion, up \$38 million, with the full month benchmark projecting an increase of \$150 million. Month-to-date tax collections reflect mostly growth in income tax withholding, sales & use tax, and corporate & business tax offset by decline in income tax cash estimated payments.

Month-to-date income tax collections through June 15, 2016 total \$627 million, up \$13 million, or 2.1% from the same period in June 2015. Month-to-date income tax withholdings total \$491 million, up \$19 million from the same period last year, with the full month benchmark projecting an increase of \$79 million (about \$45 million of the projected increase is due to last year's June to May shift, which was expected to reverse this year).

Quarterly income tax estimated payments are normally due on June 15th but most are sent in by mail and therefore deposited well after the due date. Month-to-date income tax cash estimated payments total \$144 million, down \$8 million from the same period last year with the full month benchmark projecting a decrease of \$11 million. It is very early in the month for this revenue source to be meaningful; the bulk of the payments historically come during the second half of the month.

Month-to-date income tax refunds total \$38 million, down \$0.5 million from the same period last June with the full month benchmark projecting an increase of \$0.2 million or 0.3% for the month as a whole. Income tax payments with returns and extensions are projected to total \$75 million in June, an increase of \$11 million for the month. Through June 15, 2016, these collections total \$30 million, up \$1 million from the same period last year.

Corporate & business quarterly estimated payments are due on June 15th. Month-to-date corporate and business tax collections total \$474 million, up \$21 million from the same period last year, with the full month benchmark projecting an increase of \$23 million.

As of June 15, 2016, month-to-date sales and use tax collections totaled \$96 million, up \$15 million from the same period last June, with the full month benchmark projecting an increase of \$37 million or 7.0% actual, and 6.7% baseline from June 2015. June 15th was too early in the month for month-to-date sales tax trends to be meaningful, as monthly sales tax payments (other than those for motor vehicle sales tax) are not due until June 20th.

Monthly motor fuels and rooms tax payments are also due on June 20th. There may be differences in the due dates for certain tax payments from one fiscal year to the next (e.g., in withholding payments or the timing of refund cycles) which complicate month-to-date comparisons to the prior year. As a result of these factors, revenues received through June 15th as reported in the attached table may not be indicative of what the final results for the full month will be. Specifically, they do not necessarily represent one-half of the revenues to be received in the full month and the month-to-date growth rates compared to June 2015 could change significantly by the end of this month. Any variances from the monthly benchmark at this point in the month should not be relied on as an indicator of what total final revenues for the month will be, compared to the full month benchmarks.
