This notice serves to inform you concerning activity involving hearings, decisions, and matters pending before either the Commissioner of Banks or the Board of Bank Incorporation.

### **DIVISION OF BANKS**

#### **Decisions**

<u>Greenfield Co-operative Bank, Greenfield</u> – notice to establish a branch office at 487 Newton Street, South Hadley – non-objection issued June 5, 2019.

<u>Newburyport Five Cents Savings Bank, Newburyport</u> – notice to establish a branch office at 321 Lafayette Road, Hampton, New Hampshire – approved June 5, 2019.

<u>Rockland Trust Company, Rockland</u> – notice to establish a branch office at 1450 Highland Avenue, Needham – non-objection issued June 5, 2019.

<u>State Street Bank and Trust Company, Boston</u> – permission to establish a branch office at 525 Washington Boulevard, Jersey City, New Jersey – approved June 5, 2019.

<u>Tremont Credit Union, Boston</u> – permission to amend its by-laws to expand the associations which qualify persons for membership. The amendment relative to membership eligibility proposes to now add membership for employees of the Massachusetts Biotechnology Council, Cambridge, employees of members of the Massachusetts Biotechnology Council, and immediate family members of such persons – approved June 21, 2019.

#### Applications/Notices Pending

<u>Alden Credit Union, Chicopee</u> – permission to amend its by-laws to expand the associations which qualify persons for membership. The amendment relative to membership eligibility proposes to now add (1) persons who reside, work or attend school in the Massachusetts municipalities of Brookfield, Leicester, Spencer and Worcester, and the Connecticut municipalities of Enfield, Granby, East Windsor, South Windsor, Winsor Locks, Somers and Suffield; and (2) domestic partners of eligible persons. Comment period ends July 23, 2019.

<u>Align Credit Union, Lowell</u> – permission to amend its by-laws to expand the associations which qualify persons for membership. The amendment relative to membership eligibility proposes to now add membership for individuals who live, work or attend school in Suffolk County and all cities and towns within Norfolk County that are not already included in the current by-laws, and family members of such persons. Comment period ended May 28, 2019.

<u>BayCoast Bank, Swansea</u> – notice to establish a branch office at 10 Foxborough Boulevard, Foxborough. Filed June 20, 2019.

<u>Greenfield Co-operative Bank, Greenfield</u> – permission to close its branch office located at 253 Triangle Street, Amherst. Comment period ends July 15, 2019.

North Shore Bank, a Co-operative Bank (North Shore), Peabody and Beverly Bank, Beverly – permission for Beverly Bank to merge with and into North Shore under the charter and by-laws of North Shore as part of a multistep transaction. The main office of North Shore would remain the main office of the continuing institution, and the banking offices of Beverly Bank will be retained as branch offices. This multi-step transaction includes the merger of North Shore's mutual holding company, North Shore Bancorp, with Beverly Bank's mutual holding company, Beverly Financial, MHC, with North Shore Bancorp as the continuing mutual holding company. Comment period ends July 5, 2019.

<u>Millbury Savings Bank, Millbury</u> – notice to establish a branch office at 7-9 North Street, Worcester. Filed June 13, 2019.

<u>PeoplesBank, Holyoke</u> – permission to close its branch offices located at (1) 825 Hampden Street, Holyoke; and (2) 596 South Street, Holyoke. Comment periods ended June 14, 2019.

<u>Salem Five Cents Savings Bank, Salem</u> – notice to establish a branch office at 91 Lynnfield Street, Peabody. Filed June 21, 2019.

Sharon Credit Union (Sharon), Sharon – permission to (1) merge with Crescent Credit Union (Crescent), Brockton; and (2) as part of this merger transaction, amend the by-laws of Sharon to include Crescent's current membership eligibility and change the name of the credit union to Sharon & Crescent United Credit Union. Under the terms of the Merger Agreement and Plan of Merger, Crescent will merge with and into Sharon under the charter and by-laws of Sharon. The main office of Sharon would remain the main office of the continuing credit union and all banking offices of Crescent would be retained as branch offices. Comment period ends July 23, 2019.

<u>South Shore Bank, South Weymouth</u> – permission to close its branch offices located at (1) 1515 Commercial Street, East Weymouth; and (2) 138 Franklin Street, Quincy. Comment periods end July 9, 2019.

<u>The Provident Bank, Amesbury</u> – permission to relocate its branch office from 21 Daniel Street, Portsmouth, New Hampshire to 25 Maplewood Avenue, Portsmouth, New Hampshire. Comment period ends July 9, 2019.

# COMMUNITY REINVESTMENT ACT DESCRIPTIVE RATINGS AND EVALUATIONS WHICH BECAME PUBLIC DURING THE MONTH

The following state-chartered banks and credit unions and licensed mortgage lenders have Community Reinvestment Act descriptive ratings and evaluations describing the basis for the rating issued by the Division of Banks. The ratings, as set out in statute, for a bank's or credit union's record of meeting community credit needs are: Outstanding (O); High Satisfactory (HS); Satisfactory (S); Needs to Improve (NI); and Substantial Noncompliance (SNC). Licensed mortgage lenders are also assigned one of these ratings to describe their record of meeting the mortgage credit needs in the Commonwealth of Massachusetts.

## BANK AND CREDIT UNION APPLICATION PROCESS TIMING

As a general rule, applications by banks and credit unions other than those that are subject to a review period set out in statute are intended to be processed and completed within the monthly cycle for which the bank and credit union applies. That review period for such processing is approximately 45 days or less from the date the application is filed with the Division. A decision on the application is generally issued within 5 business days after the review period is completed. The decision then will be reported on the monthly Activity Report for the month in which the decision was issued. The timing of the overall review process including the issuance of a decision and the listing on the monthly Activity Report will be dependent on the applicant's compliance with all statutory, regulatory and administrative requirements. Applications before the Massachusetts Board of Bank Incorporation are subject to separate timing schedules as set out in the applications of the Board.
