Pursuant to section 12 of chapter 53 of the Acts of 20201 which extended the April 15 personal income tax filing and payment deadline to July 15 and section 3 of chapter 78 of the Acts of 20202 which requires the Comptroller to record as FY 2020 revenue income tax payments and refunds originally due in FY 2020 but received between July 1 and August 31, 2020, the June FY 2020 Monthly Report of Collections and Refunds (the Blue Book) includes payments and refunds received between July 1 and August 31, 2020 that were originally due in FY 2020, including payments with final 2019 income tax returns, extension payments, and estimated payments original due in April and June 2020.
