Honorable Chairs and Ranking Minority Members of the Committees on Ways and Means:

Pursuant to Section 6 of Chapter 14 of the General Laws¹, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of June 2023, the last month of fiscal year 2023. The attached table shows June 2023 month-to-date tax revenue collections through June 15, 2023, along with changes from the equivalent period in June 2022.

Revenue collections are uneven and usually weighted toward month-end. The brief period covered in the mid-month report does not provide sufficient data for comparison to prior years. Therefore, mid-month figures should not be used to assess trends or project future revenues.

Context for June Revenues

In general, June is a significant month for revenues because many individuals and corporations are required to make estimated payments. Historically, roughly 11.1% of annual revenue, on average, has been received during June, making it the second or third largest revenue month of the year.

Highlights

Total Tax collections for the month-to-date period were \$2.277 billion, \$36 million or 1.6% more than the collections during the same period in June 2022. Month-to-date increases in withholding and regular sales tax were partially offset by decreases in corporate and business tax and "all other" tax.

- **Income Taxes** totaled \$1.223 billion, up \$43 million or 3.6% versus the same period in June 2022.
- Sales & Use Taxes totaled \$178 million, up \$29 million or 19.7% versus the same period in June 2022.
- **Corporate & Business Taxes** totaled \$811 million, down \$21 million or 2.5% versus the same period in June 2022.
- Other Taxes totaled \$65 million, down \$15 million or 19.1% versus the same period in June 2022.

Details

Total Income Tax of \$1.223 billion for mid-month June is comprised of the following:

- Withholding of \$734 million, up \$49 million versus the same period in June 2022.
- **Estimated Payments** of \$466 million, down \$15 million versus the same period in June 2022.
- **Returns/Bills** of \$52 million, down \$1 million versus the same period in June 2022.
- **Refunds** of \$28 million, down \$10 million (favorable) versus the same period in June 2022.

Sales & Use Tax of \$178 million is up \$29 million versus the same period in June 2022. Typically, only a small proportion of expected regular sales and meals tax remittances are received by the mid-month date. The month-to-date sales and use tax of \$178 million is comprised of the following:

- **Regular sales** tax of \$96 million, up \$30 million versus the same period in June 2022.
- Meals tax of \$25 million, down \$2 million versus the same period in June 2022.

• **Motor vehicle** sales tax of \$56 million, up \$1 million versus the same period in June 2022.

Corporate & Business Tax of \$811 million is down \$21 million versus the same period in June 2022. The month-to-date decrease is mostly due to a decrease in estimated payments, partially offset by an increase in return payments.

Other Taxes of \$65 million, down \$15 million versus the same period in June 2022, includes a number of tax categories such as motor fuels, cigarette, estate tax, room occupancy, and deeds.

DOR advises against using this data to predict trends. At the time of the mid-month report, there is insufficient tax collection data to provide a reliable estimate of full-month results.
