- You may be found in default
- A warrant may issue for your arrest.

HOW TO PAY

To Pay In Person:

Pay at the Clerk-Magistrate's Office of this court with a money order, bank check, VISA or Mastercard, or cash. (Most courts do not accept personal checks.)

To Pay By Mail:

Mail a money order or bank check made payable to "The Commonwealth of Massachusetts" to the clerk's office. Include on the money order or bank check your date of birth and docket number of the case (listed on the front of the form for which you are making payment). The clerk's mailing address can be found at mass.gov/orgs/district-court/locations.

To Pay Online:

Payments may be made online via ePay at www.masscourts.org. This requires a valid email address and the full 12 digit Docket number assigned to your case listed on the front of this form. The first two digits are the year, the second two identify the court division, and after "CR" is the case number. Add zeros before the case number until there are a total of six digits. Payment must be **received** at the Court by the date the payment is due.

If payment is not received when due, you must appear in court to avoid arrest.
